

**Treason—continued.**

4. To provide for the speedy attainder of persons indicted for high treason, who have fled from the Province, or remain concealed therein; Presented; Printed, (1837-8) 121. Ryder, to save the rights of the widow of any person so attainted, proposed and negatived, 143. Ryder added, providing, that if any person so attainted shall deliver himself up within three months after the judgment of attainder, and prove his inability to have done so sooner, he may be tried for his offence as though no such judgment had been passed, 144. Royal Assent, 448.
5. To indemnify Justices of the Peace, and others, who have acted in the apprehension and detention of persons suspected of high treason; Presented; Read, (1839) 187. *Not proceeded in.*
