Calls how made, and amount at one time, &c.

Proviso: ten per cent may be demanded on subscribing.

XIV. Calls may be made by the Directors of the said Company for the time being; Provided that no call to be made upon the subscribers for stock in the said Railway Company shall exceed the sum of ten pounds per centum upon the amount subscribed for by the respective shareholders in the said Company, and that the amount of any such calls in any one year 5 shall not exceed fifty pounds per centum upon the stock so subscribed: Provided also, that upon the occasion of any person or Corporation becoming a subscriber for stock in the said Company, it shall and may be lawful for the provisional and other Directors of the said Company, for the time being, to demand and receive to and for the use of the said Company the 10 sum of ten pounds per centum upon the amount so by such person or Corporation respectively subscribed, and the amount of such calls as shall have already been made payable in respect of the stock then already subscribed at the time of such person or Corporation respectively subscribing for stock.

XV. And whereas it may be necessary for the said Company to possess

May purchase lots of land for gravel pits, stations, &c.

gravel pits and lands containing deposits of gravel as well as lands for stations and other purposes at convenient places along their line of Railway for constructing and keeping in repair and for carrying on the business of the said Railway: And as such gravel pits or deposits cannot at all times 02 be procured without buying the whole lot of land whereon such deposits may be found; it is therefore enacted, that it shall be lawful for the said Company, and they are hereby authorized, from time to time to purchase, have, hold, take, receive, use and enjoy along the line of the said Railway or separated therefrom, and if separated therefrom, then with the neces- 25 sary right of way thereto, any lands, tenements and hereditaments which it shall please Her Majesty or any person or persons, or bodies politic, to give, grant, sell or convey unto, and to the use of or in trust for the said of such lots of Company, their successors and assigns, and it shall and may be lawful for the said Company to establish stations or workshops on any of such lots or 30 blocks of land, and from time to time by deed of bargain and sale or otherwise, to grant, bargain, sell or convey any portions of such lands not necessary to be retained for gravel pits, sidings, branches, wood-yards, station-grounds or workshops, or for effectually repairing, maintaining and using to the greatest advantage, the said Railway and other works con- \$5 nected therewith.

May dispose land as they shall not require.

Commencement of Railway.

XVI. The said Railway shall be commenced within three years and completed within ten years after the passing of this Act.

XVII. All provisions of Law inconsistent with this Act are and shall be Inconsistent enactments re- repealed from the passing thereof. pealed.

Public Act.

XVIII. The Interpretation Act shall apply to this Act, and this Act shall be deemed a public Act.
