Commenced in 1838 by MR. (after Sir) FRANCIS HINCKES, immediately after the appointment of LORD DURHAM, about three years after under SIR CHARLES BAGOT, (*a portion of whose library is now in this house, &c. me being included in this catalogue.*) Mr. Hinckes was appointed Inspector-General, but was defeated at the election under METCALF. He was a warm friend of the devoted W. L. MACKENZIE, whose Son-in-Law, Mr. Charles Lindsay, occupied the editorial chair. In 1850 the editorship was offered to Mr. Mackenzie, who was then in Washington, D.C. We need not say such items as the above abound with the best class of material for the making of history, and for which posterity a hundred years hence will seek in vain.

SIR CHARLES BAGOT was an English Diplomatist, and son of William Lord Bagot, born in 1781. He was successively Minister to France (1814) Ambassador to Saint Petersburg (1820) and to Holland (1824) He afterwards succeeded Lord Sydenham as GOVERNOR-GENERAL OF CANADA, where he died in 1843.
