THE WORLD OF SPORTS.

Annual Meeting of the Eastern League.

Championship Formally Awarded to Providence—The New Royal Yacht.

BASEBALL.

THE EASTERN LEAGUE ANNUAL. Providence, R. I., Dec. 5.—The annual meeting of the Eastern League, at the Narragansett Hotel today, brought together quite a number of baseball men. The directors of the league met shortly before noon, with T. B. Cory (Providence), J. H. Callahan (Rochester), P. H. Hurley (Worcester), E. B. Barrow (Toronto), and President Powers present. The championship of 1900 was formally awarded to the Providence club. Several communications in regard to the contested games were received, but as they would in no case alter the championship standing of the several clubs, they were withdrawn. Claims for guarantees for holiday games were received in relation to games at Syracuse on July and at Toronto on Labor Day. The directors decided that guarantee rules do not apply to holiday games, as the visiting club, on holidays receive half of everything.

Montreal's claim for half of the full rates for boys at Toronto on Labor Day was decided in favor of Montreal. Montreal played at Rochester on Oddfellows' Day, and was given only the guarantee. Montreal claims its full share of the receipts on the ground that insufficient notice was given. The matter was continued without action, as Montreal did not send a representative.

At Syracuse, on Aug. 27 the Traction Company arranged to use the grounds for a pyrotechnic display, and the ball club transferred the game to Montreal. Montreal claims the guarantee at Syracuse. The matter was continued.

The Toronto club agreed to pay to Rochester a claim of \$44.65 due on Ladies' day receipts in 1900 from the old Toronto club.

In general meeting Providence was represented by T. B. Cory, W. H. Draper and Wm. J. Murray; Rochester by J. H. Callahan and Marcus Kochenbach; Worcester by P. H. Hurley and M. J. Kittredge; Toronto by E. J. Barrows; Syracuse by Frank J. Leonard; Hartford by Charles Spafford; Springfield by Thomas E. Burns. Montreal was not represented.

The board of directors' report on the affairs of the past season was adopted, no definite action being taken on the claims entered by Montreal of minor charges against Toronto, Rochester and Syracuse, as Montreal's representative was not present.

The transfer of Toronto to the new owners, Messrs. J. H. Mack, J. H. Draper and E. C. Barrow as manager, was sanctioned.

The constitution was amended that the annual meeting of the Eastern League shall be held in New York on the first Wednesday in December. Instead of the city of the club winning the championship—a return to the old plan. The constitution was amended to fix the rate of admission for boys on holidays at 10 cents. The league adopted another amendment to the constitution providing for a guarantee of \$50 to the visiting club when a game is postponed on account of rain.

In reference to the much-talked-of agreement among the players regarding a new form of contract between the players and the club, the matter was left in the hands of the president and directors of the league. The players demand limitation to the home rights to three years with one club, and no assignment or transfer of services from one club to another without the consent of the player.

George O'Neill, of the Toronto club, was appointed a committee on transportation for the league.

In relation to sub-umpires to act when regular umpires may be absent or disabled, it was voted that the secretary of the league shall nominate two capable local men.

The league re-elected P. T. Powers for the eighth time as president, secretary and treasurer. The board of directors was elected to consist of two from each section. E. H. Hinton of Worcester; Charles Soly, of Hartford; Edward J. Mack, of Toronto, and E. F. Higgins, of Rochester.

The league adjourned to meet in New York for the schedule meeting at a date to be fixed by the president.

CHESS.

INTERNATIONAL MATCH. Cambridge, Mass., Dec. 5.—Negotiations are now on foot between the universities of Cambridge and Oxford in England and four American colleges with regard to the international chess match this year. The trophy that was given by I. N. Rice, of New York, has been won by Cambridge. Unless the American colleges win the match this year the trophy will remain the permanent property of the English university.

YACHTING.

THE NEW ROYAL YACHT. New York, Dec. 5.—A special to the Herald from London says: The troubles of the new royal yacht, according to what a correspondent of a local paper says, are far from being over. All the non-inflammable wood in the royal apartments has had to be removed, because the authorities think it might stain the delicate material with which they are to be upholstered. After the non-inflammable wood had all been put in somebody suggested that the chemicals with which the wood is treated might spoil the tapestry. A test was made at Portsmouth, and an order for the removal of the wood is said to have been the result. In some places, however, the wood cannot be got out without great trouble, and in such places it will be allowed to remain. Too much acid is said to have been mixed with the preparation by which the wood was made non-inflammable.
