THERE IS OUTSTANDING INVITATION FOR IRAQI MINISTER OF TRANSPORTATION & COMMUNICATIONS TO VISIT CANADA. VISIT EXPECTED TO TAKE PLACE IN FIRST HALF OF '87. IRAQIS PAYING OWN EXPENSES.

SUPPORT ACTIVITIES OF A MAJOR CDN SUPPLIER IN GREATER DEPTH FOLLOWING CLOSING OF THEIR BAGHDAD OFFICE.

HELP TO REVIVE PROJECT WORTH OVER CDN DOLLARS 20 MILLION WHICH IS ALSO BEING CONSIDERED FOR SUPPORT UNDER SECTION 31 GOVT FINANCING.

EXPEDITE PAYMENT OF OVER CDN 2 MILLION OWED AND/OR ENCOURAGE IRAQIS TO PRESENT PROPOSALS FOR RESCHEDULING/REPAYMENT TO CDN COMPANIES.

THERE IS HOPE THAT VISIT WILL HELP STIMULATE CONCLUSIVE CHOICE OF CANADIAN TECHNOLOGY AND TRAINING.

PROVIDE CONTINUITY OF LOGISTICAL SUPPORT FOR THIS FIRM WHICH WAS FORCED TO CLOSE OFFICE IN IRAQ FOR FINANCIAL REASONS.

QUARTER: 1 SUPPORT ACTIVITIES OF BELL CANADA INTERNATIONAL IN BAGHDAD IN REGARD TO MAJOR CONTRACT NEGOTIATIONS WITH IRAQI MINISTRY OF DEFENCE (MOD).

QUARTER: 2 SUPPORT ACTIVITIES OF BELL CANADA INTERNATIONAL IN REGARD TO MAJOR CONTRACT NEGOTIATIONS WITH IRAQI MINISTRY OF DEFENCE (MOD).

QUARTER: 3 CONTINUE SUPPORT FOR BELL CANADA INTERNATIONAL DURING FINAL STAGES OF ITS CONTRACT NEGOTIATIONS WITH IRAQI MINISTRY OF DEFENCE.

QUARTER: 4 CONTINUE SUPPORT FOR BELL CANADA INTERNATIONAL DURING NEGOTIATIONS WITH IRAQI MINISTRY OF DEFENCE (MOD).

-MAINTAINED CONTACT WITH MOD IN PREPARATION FOR FURTHER ROUND OF NEGOTIATIONS IN BAGHDAD. -PARTICIPATED IN NEGOTIATIONS, THEREBY CONFIRMING CDN GOVT INTEREST IN THIS PROJECT. -HELPED RELAY CONTRACT MODIFICATIONS.

AS ACTIVE INTERMEDIARY, MISSION HELPED TO KEEP LINES OF COMMUNICATION BETWEEN BCI & MOD OPEN IN ORDER TO ENSURE THAT LONG-RUNNING NEGOTIATIONS CONTINUE TO THEIR SUCCESSFUL CONCLUSION.

ALTHOUGH CONDITIONS WERE RIPE FOR CONTRACT SIGNATURE IN JAN 88, IRAQI MOD WAS FORCED TO CANCEL BCI'S PROJECT AS FUNDS WERE NOT RECEIVED AS EXPECTED.
