Mr. Fournier (Hull), a Member of the Queen's Privy Council, presented,—Return to an Order of the House of November 5, 1951, for a Return showing:—Is the Government, or has it been, interested and committed financially to lake shore schemes other than the Erieau Burke Drainage Scheme?

Mr. Abbott, a Member of the Queen's Privy Council, laid before the House,—Copy of a letter dated March 9, 1952, from the President of the Imperial Tobacco Company of Canada, Limited, Montreal, P.Q., to the Honourable D. C. Abbott, Q.C., Minister of Finance, Ottawa, with reference to the sale and distribution of cigarettes in Canada during the years 1949, 1950 and 1951.

Mr. Gregg moved,—That the House do go into Committee of the Whole at the next sitting of the House to consider the following proposed Resolution:—

That it is expedient to introduce a measure to amend The Government Employees Compensation Act, 1947, to extend the provision for the payment of compensation contained in section eight of the Act.

Whereupon, Mr. Gregg, a Member of the Queen's Privy Council, informed the House, That His Excellency the Governor General, having been informed of the subject-matter of the said proposed Resolution, recommends it to the House.

Resolved, That the House do go into Committee of the Whole at the next sitting of the House to consider the said proposed Resolution.

The House then resumed the adjourned Debate on the proposed motion of Mr. George for an Address to His Excellency the Governor General in Reply to His Speech at the Opening of the Session, and on the proposed motion of Mr. Fair in amendment thereto, and on the proposed motion of Mr. Bryce in amendment to the said proposed amendment.

And the Debate still continuing; the said Debate was, on motion of Mr. McCann, adjourned.

On motion of Mr. Fournier (Hull), the House then adjourned at 10.55 o'clock, p.m., until tomorrow at three o'clock, p.m.
