Hon. Howard C. Green (Acting Prime Minister): Mr. Speaker, I suggest to the hon. member that this is a matter for the courts in British Columbia; one that should be dealt with through the regular judicial bodies. [Later:]

Mr. Herridge: May I ask a supplementary question. I did not make myself clear. The point is that this is a federal matter, because these employees have put the firms into bankruptcy and there is no blighter on whom to serve notice. Everybody has disappeared. Should there not be some amendment to the Bankruptcy Act?
