Right Hon. P. E. Trudeau (Prime Minister): Mr. Speaker, I do not know if the meetings to which the Secretary of State for External Affairs has referred in this House have taken place. I do not know when they were or are to be scheduled.

[Later:]

Mr. Trudeau: Mr. Speaker, I have an answer to a question which the leader of the New Democratic Party asked me earlier, if I might be permitted to give it. It relates to the meetings between the Canadian government and the Department of State in Washington on the question of the pollution of the Pacific as a result of possible oil transportation from Alaska to the northwestern United States. I have been informed that there has been agreement to set the meetings for May 3 and they will take place on that date.

[Later:]

Mr. Speaker: I believe the hon. member for Comox-Alberni has a supplementary to the prior question.

Mr. Thomas S. Barnett (Comox-Alberni): Mr. Speaker, I have a question related to those asked by the hon. member for Nanaimo-Cowichan-The Islands of the Minister of Transport. Are any discussions or negotiations going on with the province of British Columbia leading to the establishment of permanent protective arrangements, along the lines recommended by the Arrow task force, for oil leakage prevention and clean-up on the Pacific coast?

Mr. Jamieson: Not specifically with the government of British Columbia as of this moment. However, the recommendations that came from a committee of this House and from the McTaggart-Cowan group with regard to the establishment of a contingency plan are nearly completed. Many parts of them are in fact complete, and when this is done we will be discussing them with all of the provinces that have coastal waters and that are concerned about those waters, as we are. That should be within the next month.

QUEBEC-ESTABLISHMENT OF PARK IN TÉMISCAMINQUE

Mr. Réal Caouette (Témiscamingue): Mr. Speaker, I wish to address a question to the Minister of Indian Affairs and Northern Development who is also responsible for national parks.

Are discussions taking place with Quebec authorities at the present time concerning the establishment of a national park in Témiscamingue?

Hon. Jean Crétien (Minister of Indian Affairs and Northern Development): Mr. Speaker, there are no discussions taking place at the present time concerning the establishment of a national park in Témiscamingue. I know that all Quebecers feel it would be desirable to develop national parks not only in Témiscamingue but in other areas of the province as well.

Mr. Caouette: Mr. Speaker, I have a supplementary question for the Minister.

Can he tell us if any action is now being taken by his department for the restoration of the ancient fort of Ville-Marie?

Mr. Speaker: I believe that the supplementary question could be put on the order paper. And I wish to point out to hon. members that I have always had serious doubts about questions of the kind asked by the hon. member. In any event, I assume that he has obtained the information that could be useful to him.

MEASURES TO ALLEVIATE EFFECT OF COST OF LIVING INCREASE ON PEOPLE WITH LOW INCOMES
