RADIOACTIVE CONTAMINATION OF SITES IN OTTAWA AREA-REQUEST FOR INQUIRY IN DISPOSAL OF RADIOACTIVE MATERIAL—MOTION UNDER S.O. 43

Mr. Walter Baker (Grenville-Carleton): Mr. Speaker, I rise under the provisions of Standing Order 43 on a matter of urgent and pressing necessity. In view of reports by William Bush, a scientific advisor to the Atomic Energy Control Board, that waste material from one extraction process has contaminated several sites in the Ottawa area, I move, seconded by the hon. member for Peace River:

That this House direct the Minister of Energy, Mines and Resources to launch an immediate investigation into the alleged contamination of a number of sites in the Ottawa area by radioactive waste material, and report these finding to the House along with those remedial measures he intends to take to protect the health and safety of Ottawa area citizens.

And further

That this House direct the government to initiate a public inquiry into the methods by which radioactive material is handled by industry, and monitored by the Atomic Energy Control Board to assure the safety of citizens, not only in the Ottawa and Port Hope areas, but across Canada.

Mr. Speaker: Under Standing Order 43, unanimous consent is required. Is there unanimous consent?

REQUEST FOR ASSISTANCE WITH FREIGHT COSTS ON FEED GRAINS—MOTION UNDER S.O. 43

Mr. Jack Murta (Lisgar): Mr. Speaker, I also rise under Standing Order 43 on a matter of urgent and pressing necessity, that matter being the federal government's feed grain policy in so far as it relates to the total lack of action in the area of feed freight assistance. The federal government promised over two years ago to take the necessary steps to remove or modify the feed freight assistance program, at least as far as the Montreal area is concerned, but there has never been any effort made to do so. Therefore I
