4. As was pointed out in the reply to Part 1, requests for establishment increases are normally initiated by the Commanding Officer of the Royal Canadian Mounted Police in Nova Scotia and, with the concurrence of the provincial attorney-general, are included in the program forecast. It is impossible to theorize as to what action would be taken should the provincial attorney-general not agree to proposed changes as each case must be judged on its own merits.

# PRICE DIFFERENCE BETWEEN POWDERED AND FLUID MILK

#### Question No. 1,279-Mr. Robinson:

What is the price difference for powdered milk as compared to fluid milk?

Hon. E. F. Whelan (Minister of Agriculture): Skim milk powder is sold at the retail level in various sized packages with savings per pound as the package size increases. Similarly, fluid milk is sold in various sizes of packages with savings per quart as the package size increases. Fluid milk prices per quart are generally less than half the price of a pound of skim milk powder Skim milk powder, which receives a federal subsidy of 29 cents per pound, however, is reconstituted to make four quarts from one pound. Thus the cost of one quart of reconstituted skim milk is approximately 20 cents as compared to recent Toronto prices for fluid milk of approximately 50 cents per quart. While these prices may vary across the country, the large price difference for reconstituted skim milk compared to fluid milk is always evident.
