- 1. To the date this question is answered, what would be the current all-items Consumer Price Index if calculated from 1913 expressed in terms of 1949 equalling 100?
- 2. (a) What was the all-item Consumer Price Index, if calculated from 1913 and expressed in terms of 1949 equalling 100, as of October (i) 1976 (ii) 1970 (iii) 1964 (iv) 1958 (v) 1952 (vi) 1946 (b) what was the percentage of change from the preceding six year period for each such period?
- 3. What would be the current Consumer Price Index for (a) food (b) shelter (c) services excluding shelter (d) goods other than food, if calculated from 1913 and expressed in terms of 1949 equalling 100?
- 4. What was the Consumer Price Index for (a) food (b) shelter (c) services other than shelter (d) goods other than food, if calculated from 1913 and expressed in terms of 1949 equalling 100 as of October (i) 1976 (ii) 1970 (iii) 1964 (iv) 1958 (v) 1952 (vi) 1946?
- 5. What was the percentage of change for each period in Part 4 from the preceding six-year period?
- Mr. Hugh Poulin (Parliamentary Secretary to Minister of Industry, Trade and Commerce): Statistics Canada reports: 1. The All-Item Consumer Price Index for the month of October 1976 stood at 261.3 using 1949=100 as the time reference base.
- 2. (a) The All-Items Consumer Price Index, using 1949=100 as the time reference base, stood at the following

levels for the periods specified: (i) October 1976, 261.3; (ii) October 1970, 168.3; (iii) October 1964, 135.6; (iv), October 1958, 126.0; (v) October 1952, 116.0; (vi) October 1946, 79.5. (b) The percentage change in the All-Items Consumer Price Index between the corresponding months of these six-year periods was as follows: (i) October 1970 to October 1976, 55.3 per cent; (ii) October 1964 to October 1970, 24.1 per cent; (iii) October 1958 to October 1964, 7.6 per cent; (iv) October 1952 to October 1958, 8.6 per cent; (v) October 1946 to October 1952, 45.9 per cent.

- 3. In October 1976 and using 1949=100 as time reference base, the Consumer Price Indices for the commodity groupings specified were as follows: (a) Food, 270.2; (b) Shelter, 328.6; (c) Services excluding Shelter, 385.2; (d) Goods other than Food, 197.4. It is to be noted that the composition of these groupings have slightly changed over time due to addition, deletion or reclassification of particular items. However, this does not impair the continuity of the index series since standard index linking procedures were used at time of change.
