are in operation and are handling those products as planned. The full capacity of that mining development has not yet been realized, but there is confidence that it will be.

Mr. Skelly: Get your cue cards. You have the wrong hole.

Mr. Nystrom: He is talking about the wrong mine.

Mr. Layton: With regard to the arrangements and good will that exist between this Government and the B.C. authorities, I can assure the Hon. Member personally, Mr. Speaker, that in my dealings with the provincial Minister of Mines we are very confident the working relationships between our Governments will bring benefits to the citizens of British Columbia.

FEDERAL UNIONS—GOVERNMENT POSITION

Mr. Jean-Robert Gauthier (Ottawa-Vanier): Mr. Speaker, my question is directed to the President of the Treasury Board.

Last April 17, the President of the Treasury Board made a major statement in the House concerning four points under negotiation with federal labour unions. He stated there was agreement with labour on a master agreement, a dental plan, a revised pension plan and improved workforce adjustment procedures. Now we learn that the largest union, the Public Service Alliance, simply refuses to endorse the agreements—or to go along with the other unions—and rejects both the revised pension plan and the dental plan.

May I ask the Minister what he is going to do now that the largest union has refused to go along with that decision?

Hon. Robert de Cotret (President of the Treasury Board): As everyone knows, Mr. Speaker, what I announced was an agreement in principle which was to be submitted for concurrence to each union and, in our case, to the Cabinet. Quite obviously one of the 14 unions has revised its position since last month. I therefore intend to sit down with them for a new bargaining round, hopefully to reach agreement on issues raised in recent years which are of interest to our Public Service employees.
