FIRST EDITION. A QUESTION IN LAW.

WHAT COUNCIL FOR THE BRITISH LEGATION HAS TO SAY. The question is, Not What Say the United States do in Behring Sea, But What Has It Done?

WASHINGTON, D. C., Jan. 16.—Mr. Calderon Carle, counsel for the British legation, makes the following statement about the Behring sea case in the Supreme Court: "The question raised by the suggestion that the British problem is not a question of law, but a question of fact, is a question of the existing laws of the United States. That position is the chief province of the judiciary, and is the only question submitted to the Supreme Court. Should that Court hold that there are no existing statutes or treaties of the United States which, under the construction given by the district court of Alaska, have deprived British subjects of nearly \$500,000 worth of property, the question is not what may the United States do in Behring sea, but what has it done?"

If the United States claims the right of property in either the high sea or its adjacent waters, the British are bound to follow the law, whatever diplomatic negotiations may be in consequence with the other nations.

It is not to be presumed that the Supreme Court will decide any question adversely to the United States erroneously and there seems to be no just ground for supposing that Great Britain will be so inconsiderate as to demand compensation and construction, not of any diplomatic situation or of a domestic law, but of the United States from the district court of Alaska, whose decisions under existing law are not available either by appeal or writ of error.

Certainly all parties concerned are entitled to all interpretation of the existing law, but the United States is an aggressive power. That is all that is sought and is precisely what the executive and legislative branches of the United States are constitutionally disqualified to give.

IN ENGLAND AGAIN. Mr. Minister Lincoln returned today to his residence to be interviewed. STURMARTON, Jan. 16.—The United States Minister arrived here this morning on the steamer Saxon. He refused to be interviewed by any one of a number of newspaper representatives who had come from many parts of England in the hope of obtaining the views of the United States Minister on the Behring sea dispute.
