

RAILS, STEEL:—Motion (Mr. Blake) for Statement showing quantity of steel rails and fastenings bought by Government in 1879, and average price thereof, quantity already delivered and used, &c.; Amendment proposed by Mr. Plumb that Statement include quantities of rails and fastenings purchased in the years 1874-75-76, with price thereof, 64. Further amendment by Sir R. Cartwright that Statement also include quantities of rails bought since 1st January, 1871, with prices thereof; Amendment to the amendment agreed to; Amendment, as amended, agreed to; Main Motion, as amended, agreed to, 65. 1. Standing Committee on Railways, Canals and Telegraph Lines appointed, 11, 37. Members added, 44, 61, 191. Bills referred, 71, 193, &c. Reports on various Bills, 213, 248, 264, 292, 302, 313, 355. Committee report that they have amended the Preamble of a Bill, 264. Recommending that special Railway Maps be prepared for the use of the Committee, 281. That time for reception of Reports on Private Bills be extended, 292. That they have granted more extensive powers to a company than were asked for in their Petition, 313.
2. Petition of Messrs. Bourgooin & Lamontagne, for Legislation affording them a remedy to obtain compensation under provision of Railway Acts of 1868 and 1879 in relation to certain Railways, 59.
3. Petitions praying for passing of an Act to prevent purchasing of passenger tickets which have been used but not marked, and reselling same at rates less than proper fare: Canada Central Railway Co., 116; Credit Valley Railway Co., 78; Grand Trunk Railway Co., 71; Midland Railway Co., 190; New Brunswick and Canada Railway Co., 151; Northern Railway Co., 166; Port Dover and Lake Huron Railway Co., 106; St. John and Maine Railway Co., 172; Stratford and Huron Railway Co., 116; Whitby, Port Perry and Lindsay Railway Co., 124.
4. Bill respecting sale of Railway Passenger Tickets (Mr. Kirkpatrick); Ordered; Presented, 160.
5. Petition praying that Petition of Grand Trunk Railway Co. in favor of foregoing Bill may not be granted, but that said Company may be compelled to desist from extortion practised by them on people of Canada, 164.
6. Bill for constituting a Court of Railway Commissioners for Canada, and to amend the Consolidated Railway Act, 1879 (Mr. McCarthy); Ordered; Presented, 69. Motion for second reading; Amendment moved, to postpone second reading six months; Debate thereon adjourned, 189. Resumed and further adjourned, 209.
