VII. Every Elector qualified to vote at the election of a Member of the Legislative Assembly or of the Legislative Council, may vote at any one of the polls held for the city, town, village, parish or township, or for any other place forming part of a county or electoral division, in which he is qualified to vote.

VIII. Every elector, before voting, shall deliver to the Deputy Returning Officer his certificate of qualification, and if required by the Deputy Returning Officer, or one of the candidates, or his representatives, or by any elector whose name is inscribed on the list of voters, he shall take the oath contained in Schedule B, hereunto annexed.

IX. The Clerk, Secretary or Secretary Treasurer, and any Deputy Clerk, Secretary or Secretary Treasurer, on the affidavit of a duly qualified elector, that his certificate of qualification has not been delivered to him, or that he has been deprived thereof by fraud or violence, or that he has lost it by any accident, shall furnish to such elector a second certificate of qualification, under the same number as the first, stating thereon that it has been issued on the affidavit of the elector.

X. It shall be lawful for any Deputy Returning Officer, for any candidate and for any duly qualified elector, to require from the bearer of the certificate of qualification issued in virtue of the preceding section, besides the oath mentioned in Schedule B, that he should produce a person to identify him, and to whom the Deputy Returning Officer shall administer the oath contained in Schedule C.

XI. When two votes shall have been given at the same election in virtue of certificates issued under the same name and number, the second only shall be valid, and shall be counted in the addition of the votes given at such election.

XII. The taking and entering of the votes for any election of members of the Legislative Assembly, or of the Legislative Council, shall take place on the 30th day, to be computed from the date of the Writs of election or on the following day, if the 30th day be a Sunday or a legal holiday.

XIII. The Writs of election for general elections of members of the Legislative Assembly, shall be dated on the same day, and shall indicate the day on which the votes are to be taken.

XIV. The Writs of election for the periodical elections of members of the Legislative Council, shall be dated the same day, and shall indicate the day on which the votes are to be taken.

Penalties.

XV. Any Clerk, Secretary, Secretary-Treasurer or any Deputy, who recordingly issues certificates of qualification to other persons than those whose names are regularly inscribed on the lists of voters, or who issues more than one certificate for each name inscribed on the voters' list, except in the cases provided for by the 9th section of this Act, shall be liable to a fine of £50 for every such offence.

Penalties.

XVI. Any Clerk, Secretary, Secretary-Treasurer or Deputy, and any Deputy Returning Officer who neglects or refuses to fulfil any of the duties imposed upon him by this Act, shall be liable to a fine of not less than five pounds currency, nor more than fifty pounds currency, for each offence.
