And it was carried in the affirmative.

To the High Sheriff of Queens County, the sum of £25, for executing a Writ of Election and returning a Member to serve in General Assembly.

To James Whitney and others, the sum of £150, to enable them to run a good and sufficient Steam Boat between Annapolis, Digby and St. John, for seven months and a good and sufficient vessel for the remainder of the year, provided the said Proprietors carry the Mail, if required, without any additional charge; the said sum of money to be drawn when it shall be proved to the satisfaction of His Excellency the Lieutenant-Governor or Commander-in-Chief, that the services have been performed.

To the joint Committee of the Council and House of Assembly, appointed to inquire and report on the subject of a Penitentiary, the sum of £50, to defray the expense of printing the Report and other incidental charges, and also to enable them to procure any plans and documents which they may deem necessary for the information of the Legislature.

That the sum of 25*l.* granted in 1828, to the late Robert Reid, formerly High Sheriff of Northumberland, be re-appropriated and granted to Agnes Reid, widow of the late Mr. Reid, to relieve her in her present distressed situation.

To His Excellency the Lieutenant-Governor, the sum of 75*l.* for the services of a Tide Waiter at Miramichi, for the year 1829.

To His Excellency the Lieutenant-Governor or Commander-in-Chief, a sum not exceeding 50*l.* to defray the necessary expense of repairs required on the buildings adjoining the Province Hall; and of painting the Supreme Court Room.

And the Chairman further reported that he was directed to ask leave to sit again.

Ordered, that the Report be accepted and leave granted.

Mr. Humbert moved the following Resolution.

“Whereas upon consideration of the Petition of Daniel Green, complaining of the injuries sustained by reason of imprisonment on a Warrant from the late Solicitor General,

“Resolved, that the High Sheriff of King's County, be summoned forthwith to appear at the Bar of this House, to give such evidence as may be required of him, touching the said Petition.”

To which Resolution the following amendment was moved by Mr. Parker.

“Whereas it appears to this House that the injury complained of by Daniel Green, may be redressed in the ordinary course of legal proceedings: Thereupon resolved, that the Petition presented by the said Daniel Green to this House, praying further interference, be dismissed.”

And upon the question for adopting the amendment, the House divided.
