Mr. H. R. Ballard (Calgary South): A supplementary question, Mr. Speaker. Will the Prime Minister also indicate in connection with the question raised by the hon. member for Simcoe East that urban municipalities find it increasingly difficult to finance necessary works which are to be effective in the area of air pollution?
