Mr. Bernard Dumont (Frontenac): Mr. Speaker, I regret that we cannot get the unanimous consent of the house so that the hon. member for Champlain (Mr. Matte) may carry on with his very serious remarks.

I would like to express my views, as a father, on this fair amendment to the omnibus bill. This proposed amendment suggests a reform which I think is quite justifiable. Such is the conclusion reached by Dr. Walsh.

Mr. Speaker, in the light of this evidence, it is easy to understand how important it is for the doctors, the psychiatrists and all those who might be requested to perform therapeutic abortions, to be in possession of all the necessary information on the condition of the patient.

How could we not feel shocked when we think of the incredible number of hon. members who close their ears to such statements? Fortunately, there are still, on the opposition side, free people who are not afraid of calling upon the whole country to witness the war they are waging for the sake of principles which are so important and so essential to the honour of the country.
