#### POLICIES TO HALT DECLINE IN PRODUCTION

Hon. Robert L. Stanfield (Leader of the Opposition): Mr. Speaker, I would like to ask the Prime Minister whether, in view of the report of the OECD that Canada is the only one of 12 industrial countries to show a slump in industrial production this year, he will say that the government is considering any new policies to halt this decline and to provide adequate employment opportunities in this country?

Right Hon. P. E. Trudeau (Prime Minister): Mr. Speaker, I am informed that this situation arose because of the high number of strikes which were in industries under provincial jurisdiction.

Mr. Stanfield: I take it, Mr. Speaker, that the position of the government is that its general economic policy is functioning just as beautifully as its anti-inflationary policy?

### CANADIAN SOVEREIGNTY

#### USE OF ARCTIC WATERS BY PROPOSED U.S. OIL TANKERS

Mr. Ian Watson (Laprairie): Mr. Speaker, I wish to direct a question to the Prime Minister. It relates to the announcement the day before yesterday by General Dynamics Corporation that it intends to build six 200,000 ton submarine oil tankers to transport oil through the Northwest Passage, and has made an offer to sell these tankers to six major oil companies involved in the Prudhoe Bay oil field. Since this offer was quite specific, mentioning costs and delivery dates, I would like to know whether the Prime Minister could indicate whether the government of Canada or any government department has been consulted regarding this proposal?

Hon. Mitchell Sharp (Secretary of State for External Affairs): Mr. Speaker, I have not been informed and I thank the hon. member for this information. We will be inquiring into it. As the Prime Minister said in answer to a similar question on this subject, the government's policy with relation to the Arctic waters will be announced in the second part of the session.

## ACTION TO PREVENT TAKEOVER OF CANADIAN COMPANIES BY FOREIGN FIRMS

Mr. Max Saltsman (Waterloo): Mr. Speaker, I would like to direct my question to the Minister of Consumer and Corporate Affairs. In view of the startling figures tabled as a return on December 15 this year, showing that since 1963, 606 Canadian firms have been taken over by foreign corporations, can the minister indicate if he is considering specific action to examine and, if necessary, to prevent such foreign takeovers?
