THREAT POSED BY TANKER TRANSPORT OF OIL FROM VALDEZ, ALASKA, TO CHERRY POINT, WASHINGTON

In view of the unanimous decision by the British Columbia legislature on February 4, 1971, calling on the federal government to stop oil tanker shipments from Alaska to Washington state, I ask the Secretary of State for External Affairs whether he has made direct representations to the United States government in an endeavour to halt oil shipments over the route from Valdez, Alaska, to Cherry Point, Washington?

Hon. Mitchell Sharp (Secretary of State for External Affairs): So far as I know, no definite arrangements have yet been made for any such shipments. We have the situation under very close examination and at the appropriate time we will make representations. We do not think this is the time.
