minister to suggest to General Steel Wares, the potential purchasers, that they seek an extension. I am waiting until after the question period to meet with my deputy. I have no reason to believe that that extension will not be sought. I have had representations from various groups which the Minister of Labour has brought here and I have given them that assurance that we will look for the extension. If it occurs, then further discussions will continue, starting I believe tomorrow, with representatives of GSW and then the other companies involved in subsequent days over whatever the period of extension is.

### BROADCASTING

ESTABLISHMENT OF FRENCH LANGUAGE TELEVISION STATION IN BRITISH COLUMBIA—REQUEST THAT WORK ON TRANSMITTER BE STOPPED

Mr. John Reynolds (Burnaby-Richmond-Delta): Mr. Speaker, my question is for the Acting Minister of Communications. In view of the fact the CRTC hearings will not be held in Vancouver until February to decide whether or not British Columbia should have a French language television station can the minister assure the House that all work is stopped in respect of setting up the transmitter on Mount Seymour for that station?

Hon. Otto E. Lang (Acting Minister of Communications): I cannot, Mr. Speaker, but I can assure the hon. member that the question of any broadcasting would depend upon a proper license.
