A. The Acting Medical Director at the Regional Psychiatric Centre, Abbotsford is Dr. Ali F. Saad. (a) Date of appointment to present position: January 1, 1982. \*(b) Position held prior to present appointment: Clinical Director at the Regional Psychiatric Centre, Abbotsford, B.C. (c) Salary range: \$52,192 to \$63,152. \*(d) This position requires graduation from a recognized school of medicine and certification in a medical specialty recognized in Canada by a statutory licensing body.

B. There is no Deputy Director at the Regional Psychiatric Centre, Abbotsford but the Clinical Psychiatrist, Dr. Luke Glancy, is presently designated by the Acting Medical Director to act in his absence through a Commissioner's Directive issued in accordance with Section 29(3) of the Penitentiary Act.
