fair share, the money would be there to make some sound investments on behalf of the people of Canada rather than to sell them out as the Government is doing with this Bill.

This is a sad day for Canada. The Government does not want to lead, it wants to respond. It does not want to take the initiative to say that foreign investment by itself is not good. The Government does not want to admit that public opinion sometimes has to be translated into the proper perspective and plans. Eighty per cent of Canadians want greater control of our economy by Canadians. The Government should be working on getting the savings out of the bank. That will not happen through capital gains and RRSPs. The Canadian population is much too—if you will pardon the expression—"conservative".

Some Hon. Members: Hear, hear!

Mr. Angus: That is small "c" conservative as opposed to big "C".

An Hon. Member: Back to parks and recreation.

Mr. Angus: It has been suggested that I should go back to parks and recreation. At least we knew how to plan for the betterment of Canadians.

Mr. Epp (Thunder Bay-Nipigon): They are busy privatizing that too.

Mr. Angus: That is right, they are busy privatizing parks and recreation these days.

The clock is moving forward to the end of what little gains were made over the last 10 years to control our own destiny. In conclusion, I will be proud to stand up as a Canadian to vote against this legislation.
