In the U.S. ruthless corporate managers have savaged workers' jobs, wages, and working conditions, brought chaos to passengers and shippers, and cut corners on safety and maintenance". We must not allow Air Canada to become Air Texas.

COMMITTEE'S LITERACY SKILLS RECOMMENDATION

LOBBYISTS

CALL FOR AMENDMENT OF BILL C-82

Mr. Don Boudria (Glengarry—Prescott—Russell): Mr. Speaker, this week a legislative committee is studying Bill C-82 on the registration of lobbyists. The Bill has some gaping omissions.

First, the Bill does not prohibit lobbyists from charging contingency fees. This means that a lobbyist can charge an extra fee contingent on the outcome of the lobbying activity.

In most provincial jurisdictions this type of practice would be prohibited. Why should it not be prohibited for lobbyists as well? Second, the activity of information gathering for the purposes of lobbying is not addressed in the Bill.

Third, the goal of transparency of the lobbying industry is thwarted in the distinction between Tier 1 and Tier 2 lobbyists in the Bill.

I urge vigilant Members of the House to lobby our legislative committee to amend the effects of the lobbying effort of the lobbyists on the lobbying Bill.

ADMITTANCE OF REFUGEES—GOVERNMENT POLICY

Mr. Dan Heap (Spadina): Mr. Speaker, the Minister of Employment and Immigration (Mrs. McDougall) keeps repeating the high sounding principle that Canada cannot morally allow economic refugees to use up the spaces allotted to real refugees. She is busily deporting Turks to prove her point.

However, during the past two years Canada has doubled the number of so-called refugees selected abroad for entry into Canada from Nicaragua. What is going on?

Nicaragua does not have the busy death squads such as Chile, El Salvador, and Guatemala. The United Nations and Amnesty find that Nicaragua's performance on the rule of law and human rights is clearly better than those countries, and the Central American Verification Committee found Nicaragua the only country seriously complying with the Esquipulas cease-fire agreement.
