

What he did was wrong, publishing the addresses of shelters for battered women. It was wrong. It did put women into increased danger. It was not intentionally wrong, I understand that, but it was wrong all the same.

**Mr. John Nunziata (York South—Weston):** Mr. Speaker, on the same point, the member seems to persist. In her comments, she again states that the member for Broadview—Greenwood has put women at risk by doing what he did. I find that unacceptable.

I rise to support the point of privilege raised by my colleague, the member for Broadview—Greenwood. Let us put this matter into perspective. I believe that the member for Broadview—Greenwood put it into perspective this morning when he indicated the background to the dissemination of that particular information.

He was giving a speech in the House of Commons on the issue of violence against women and children. He was commenting about a publication entitled *Women's Country* which was given to him by a victim, a battered woman. He was subsequently called for information about women's shelters. In his opinion and in his judgment he felt that information was needed for women who are in that situation to provide information where these women might go to seek out help.

The member, as the member who just spoke, was trying to be helpful. Yet the member who is accusing him of putting women at risk, and I would submit for political reasons given the nature of my colleague's opposition that being a former NDP, chose to rise in the House of Commons—

**The Acting Speaker (Mr. DeBlois):** Please. On a point of order the hon. member for Churchill.

She knows that, yet she chose in her selective submissions not to point that information out. Perhaps she can take issue with hostels like Nellie's in Toronto and other hostels that publish that information. Rather than speaking to the member privately, the NDP member chose to rise in the House to give the issue a higher profile to score some cheap political NDP points by attacking the hon. member.
