## WANTS CROWN RESERVE STOCK

Action entered by Montreal to Get \$100,000 Worth.

MONTREAL, Sept. 21.—(Special.)—There is important litigation on in connection with the Crown Reserve Mining Company.

The action returned to-day in the superior court entered by A. G. Fowler-Ross is one whereby he seeks through his attorneys, Wells & Company, to recover from a syndicate which largely owns and controls Crown Reserve stock to the amount of \$100,000. The parties against whom the action is taken are John Carson, R. W. Garth, D. W. Lockerby, and W. I. Greer, all of Montreal, and Jas. Curry, J. Gallagher, John L. L. and C. E. Porter, all of Toronto. The defendants, who are represented by Foster and Martin, deny plaintiff any right to the whole or any part of the mining stock in question.

The action should in no way affect the value of the stock held either by the City of Montreal or by the City of Toronto.

Do Good Work at Blaze Just Outside City Limits.

Laying out 1500 feet of hose supplied by the College and Ossington hose wagons, and pumping water thru the "teapot" engine from Yonge-street which had answered its first trial alarm, Deputy Chief Noble succeeded in curbing a dangerous fire on Howland-avenue, in the county yesterday afternoon, and saved a block of valuable buildings.
