

Aug., 1877. Became Attorney-Gen. in the Administration of the Hon. William Smithe, 26 Jan., 1883. On the death of Mr. Smithe in March, 1887, succeeded him as Premier and President of the Council. First returned to Leg. Assem. for Cariboo, at g.e. 1875. Defeated on offering for re-election on his appt. to office in 1877. Was not a candidate at g.e. 1878. Re-elected for present seat at g.e. 1882 and on appointment to office, and again at last g.e. A Conservative.—*Victoria; Union Club, Victoria, B.C.*

DAVIE, Hon. THEODORE, Q.C. (*Victoria City.*)

S. of John Chapman Davie, Esq., formerly of Lyme Regis, Dorset, Eng., Surgeon, and M.R.C.S. Eng., who came to B.C. in 1862 and was at the time of his death, May, 1869, a mem. of the Leg. Assem., B.C. B. 22 March, 1852, at Brixton, Surrey, Eng. M., 14 Jan., 1884, Alice Mary, only dau. of the late Gregory Yorke, of Galway, Irel. Shipowner. Ed. at a private school. Admitted to practise as an Attorney, 16 April, 1873, and called to the Bar, B.C., 16 April, 1877. Apptd. Q. C., 7 June, 1888. Is a Bencher of the Law Soc., B.C. First returned to Leg. Assem. at g.e. 1882, and re-elected last g.e. Apptd. a mem. of the Ex. Council, 7 Jan., 1888.—*Victoria, B. C.; Rideau Club, Ottawa.*

DUCK, SIMON. (*Victoria City.*)

Parents were amongst the earliest settlers of St. Catherines, Ont. B. and ed. there. M. Mrs. Sarah Miller of Victoria. Has been Grand Senior Warden of the Grand Lodge of Freemasons of B.C. First returned to Leg. Assem. for present seat, Oct., 1871. An unsuccessful candidate at g.e. 1875. Was not a candidate at g.e. 1878. Re-elected at g.e. 1882. An unsuccessful candidate at last g.e. Re-elected at bye-election, 25 Jan., 1888, to fill vacancy made by resignation of E. G. Prior who was subsequently elected to the Commons.—*Victoria.*

DUNSMUIR, Hon. ROBERT, J. P. (*Nanaimo.*)

Grandfather and father were Coal Masters in Ayrshire, Scot. B. in Hurlford, Ayrshire, Scot., in 1823. M., in Kilmarnock, Scot., in 1847, Joanna, dau. of Mr. Alex. White. Ed. at Kilmarnock Academy. Is an extensive Colliery proprietor and shipowner. Is President of the Esquimault and Nanaimo Railway, and a J. P. Apptd. President of the Council (without salary) 8 Aug., 1887.
