IMPEACHMENT OF THE PRESIDENT.

Impeachment has dragged its slow length along until we are about to see the end of it. On Thursday last the Senate sat for six long hours in secret session, the question before it when the doors were closed being Mr. Sumner's resolution prescribing the manner in which the final vote on the impeachment articles should be taken. From what busy reporters afterwards gleaned from garrulous Senators it would appear that a large number of motions, or rather amendments to an original motion, for adjournment to a certain day, and the fixing of a day for the final vote, were brought up and negatived. Mr. Sumner's resolution to vote at once was rejected, so was Mr. Morrill's resolution to vote on Monday. This gentleman modified his order until it stood as follows:—"That when the Senate adjourn to-day it adjourn until Monday at 12 o'clock meridian, for the purpose of deliberating on the rules of the Senate, sitting on the trial of impeachment; and that on Tuesday next following, at 12 o'clock meridian, the Senate shall proceed to vote, without debate, on the several articles of impeachment, and each Senator shall be permitted to file, within two days after the vote is taken, his written opinion, to be printed with the proceedings."

On Tuesday, then, the question will be settled, and Andrew Johnson's tenure of the White House determined. The day will be an important one in the history of the Republic as well as in that of the President. There is a rule for the regulation of voting in the Senate which is as follows:—On taking the votes of the Senate on the articles of impeachment, the presiding officer shall call each Senator by his name, and upon each article proposing the following question in the manner following: Mr.—How say you; is the respondent—guilty or not guilty, as charged in the—article of impeachment? Whereupon each Senator shall rise in his place and answer "Guilty," or "Not Guilty."

IMPEACHMENT OF JUDGES.

A few days ago a petition from lawyers, and other citizens of Aylmer, County of Ottawa, was presented to the House of Commons against Justice Lafontaine, charging him with forgery, incapacity, falsification of the Court records, and defalcation of Government money while he was Crown Lands Agent. It is understood that his Lordship will be impeached before the House. Another Lower Canadian judge, Justice Drummond is likely to be proceeded against in like manner. Mr. Chamberlin has presented the petition of T. K. Ramsay, accusing and impeaching the judge of malicious and infamous proceedings against the Petitioner in the Lamirand case; of being a notorious drunkard; of being an insolvent and fraudulent debtor, and abusing his position as a Judge to prevent the seizure of his effects; of using his position in 1864 to secure by bargain and money consideration the resignation of Justice Bowen and taking his seat. These are very serious charges, and every person will admit that no man is fit to be an administrator of that law which he violates so wantonly. The interest that will be felt in the proceedings connected with the impeachment of these two Justices will not be slight, since if the accusation be substantiated the unpleasant truth must be forced to the surface, that the Bench of Canada, which has hitherto been considered a close approximation of purity, has been disgraced by the venality of two prominent judges.

THE PROVINCIAL ARBITRATORS.

—Judge Day, arbitrator for the Province of Quebec, has been in Ottawa for a few days. It is said the Finance Department is not yet ready with a statement, so that the arbitrators can go to work to settle the accounts between the Province and the Dominion.

The German Zollverein Parliament has, by a large majority, rejected the address from the Party of German Unity. The Cable has not informed us of the contents of this address, but it probably prayed for an enlargement of the functions of the Zollverein Parliament so as to make it in every respect the Parliament of the German Nation, and thus complete the National unity. The large majority against the address indicates that the Government of Prussia has used its influence against it. Prussia desires a strong current of public opinion in South Germany that shows itself at present in favor of a union before she is willing to assume

OUR RAILWAY DEBT.

At the last meeting of Council the Railway Committee presented a Report, recommending to the Council the consideration of an early application to Parliament to be relieved of the amount of railway debt incurred by the town, on the ground that the same was incurred in furthering railway extension, not merely for local purposes or benefit, but in the railway interest generally. The Council were prompted to take this step by the action of the Government in reference to the debt due the country by the Great Western Railway. They consider that if a wealthy Railway Company like the Great Western is to be forgiven the whole or part of its indebtedness to the Government, a corporation which borrowed \$20,000 to help to build railways not only for the benefit of the Municipality but of the whole surrounding country, should also be dealt with in the same liberal spirit. This is sound reasoning, and our Council deserve all due credit for initiating a movement which may, and ought, ultimately, to lead to the wiping out of the debt due by this Corporation for railway purposes.

But while the Council are right in their general argument and reasons why the Corporation should be relieved from this debt, some of the members are wrong in the comparison they attempt to draw between the case of the Corporation and that of the Great Western Railway. There is no parallel in the two cases: That of the G. W. Railway is a direct debt to the Government—the railway debt of our Corporation is a debt due to a special fund, which fund since Confederation is in an unsettled state as to its proprietorship. This is one of the subjects which the Provincial arbitrators will have to take into consideration. They will have to decide to what particular Government it belongs, and perhaps also as to the extent of the liability of each Municipality which borrowed from the Municipal Loan Fund. The Federal Government therefore at the present stage cannot, and will not interfere. The petition of the Council is therefore premature as far as any immediate relief is concerned, but otherwise it is a step in the right direction, and may ultimately lead to our being remitted a debt, the incurring of which was as much a benefit to the country as to the Municipality.

Our opinion in regard to this subject is confirmed by a letter from Mr. Stirton to the Mayor, under date of May 4th. Our member with that attention and solicitude for the interests of Guelph which he has manifested on all occasions, had been making inquiries in regard to this debt before the Council took any action in the matter, and wrote to the Mayor as follows:—

HOUSE OF COMMONS, Ottawa, May 4, 1868. N. Higginbotham, Esq., Mayor of Guelph. DEAR SIR,—Supposing the Council of your good Town would feel some interest as to the course which will be pursued by the Government in relation to the Upper Canada Municipal Loan Fund, I have made the necessary inquiry of the Minister of Finance. He informs me that this Fund, and all its relations, will be referred to the arbitrators recently chosen by the respective Governments of Ontario, Quebec and that of the Dominion. No action will or can be taken by the Federal Government in regard to the indebtedness of any Municipality to this Fund, until it is first decided by the arbitrators in question what disposition shall be made of the said Fund. 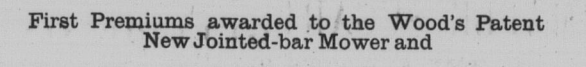
