**FIVE CHARGED WITH**  
**AUTOMOBILE THEFT**  
**BOOKED FOR TRIAL**

Will Appear Before Judge  
 Macbeth in Few Days  
 To Elect.

Chester Roe, Orville Restorick, George  
 Grant, George Langridge and Clarence  
 Gresson were committed by Squire W.  
 H. Chittick at the courthouse Friday  
 afternoon for trial on a charge of theft.  
 They are alleged to have stolen an auto  
 belonging to George Geoghegan in West-  
 minister Township. They will probably  
 appear before Judge Tabbot Macbeth  
 within a few days to elect whether they  
 wish to be tried by judge or jury.  
 Joseph Soden declared that on July  
 1 Chester Roe visited the garage at  
 which he is employed at Ingersoll for  
 repairs. He said that after he left he  
 missed a cushion and other articles.  
 Later, Soden came to London to investi-  
 gate the matter and to see Roe's car.  
 He learned from Roe that four other  
 young men had taken Roe's car to Ham-  
 ilton for a trial. Soden was asked, he  
 said, if he could handle stolen cars and  
 other stolen property. He said that he  
 thought he could.  
 There was a car stripped of tires and  
 other parts on a seldom-travelled road  
 between Springfield and Komoka. He  
 was told of another car hidden in the  
 upper part of a barn. He arranged to  
 go to the former place and get the car.  
 An hour later he told the local detec-  
 tive department of his findings and de-  
 tectives Harry Down and Thomas Bol-  
 ton, along with George Geoghegan, went  
 to the spot Soden described and found  
 several parts.  
 On July 22, the detectives met Soden  
 coming from Niles town and "get  
 line" on the five accused. They found  
 three of them on the road in the vicin-  
 ity of one car and chased the other  
 two, who fled in a second car. They  
 overtook them and brought the five men  
 and the two cars to police headquarters.  
 Constable Matthew Easton saw the  
 five accused on Layard street pumping  
 wind into a tire on a car, about four  
 hours after Geoghegan's car was re-  
 ported stolen. He positively identified  
 the five as being the men who were  
 there.  
 In one of the cars the police found  
 a raincoat and a pair of shoes which  
 they claim were stolen and were the prop-  
 erty of Geoghegan.  
 J. M. Donahue, solicitor for Clarence  
 Gresson, contended that his client should  
 not be sent for trial as there was no  
 evidence to show that he was connected  
 with the theft of the car. Squire Chit-  
 tick said that Constable Easton's evi-  
 dence particularly impressed him that  
 the whole gang were implicated in the  
 matter. W. E. Henderson and E. W.  
 Scatcherd were other counsel for the  
 defence.  
 A Crown Attorney J. B. McKillop, K.C.,  
 declared that all five should certainly  
 be sent for trial.

**MORE PROTECTION TO**  
**PUBLIC IN SALE OF**  
**STOCK WILL BE URGED**

**Chamber of Commerce to**  
**Consider Special Resolu-**  
**tions—Major Chisholme**  
**May Come Here.**

Because it is believed that existing  
 laws governing the sale of stock in  
 Ontario do not afford sufficient pro-  
 tection to the public, the directors of the  
 local Chamber of Commerce voted  
 unanimously at a meeting on Thursday  
 to adopt a report of a special commit-  
 tee in which several recommendations  
 were made. The recommendation, how-  
 ever, will not be made public until after  
 they come before the members' council,  
 when if they are given a favorable re-  
 ception they will be passed on to the  
 Provincial Government.

The directors decided to exhibit the  
 great picture of London taken from the  
 air by the Geodetic Survey of Canada

at the Western Fair. The picture when  
 completed will measure approximately  
 ten feet square, and it will show every  
 house, pole and other natural and arti-  
 ficial feature of the city. The picture will  
 be on exhibition in the Agricultural  
 Building.

**LECTURE IN LONDON**

Samuel M. McClure, publisher, author,  
 and lecturer, the founder of McClure's  
 Magazine, will in all probability come
