EFFECT OF RATE CHANGES ON NON-PROFIT PUBLICATIONS

Mr. Heath Macquarrie (Hillsborough): Mr. Speaker, I should like to direct a question to the laconic Postmaster General. It concerns the increasing number of trade union and other non-profit publications going out of business on account of increased postal rates. Can he advise if he is prepared yet to take another look at this serious matter, with a view to forestalling further shrinkage in the publishing industry?

Hon. Eric W. Kierans (Minister of Communications): Mr. Speaker, I think I have replied on many occasions that the labour journals and indeed many other non-profit publications could recover all of the increases in the postage rates by a very nominal increase in their subscription rates, sometimes as low as something in the order of 17 cents or 25 cents a year. I reiterate my belief that I do not think these journals can expect the postmen, the whole 48,000 of them, to continue to subsidize these journals.
