Motor licence: decrease of \$6,701 due to the fact that the entrance fee was reduced from \$2.00 to \$1.00 and also due to the wet summer. Docking: decrease of \$7,539—a revised fee schedule allowed lower docking charges for most boats. In some cases, the fee was 50 per cent lower than in 1975. The wet summer also reduced usage.
