The Acting Speaker (Mr. Ethier): Order, please. Remarks should be addressed to the Chair and not to hon. members. Therefore, I will allow the Right Hon. Leader of the Opposition to continue.

Mr. Clark: Thank you, Mr. Speaker.

Some hon. Members: Hear, hear!

Mr. McDermid: He cannot stand the heat!

Mr. Simmons: Tell us about Jerusalem! Where do you stand on Jerusalem?

Mr. Clark: I am sure Your Honour will calculate the amount of time which has been taken from my speech by the various interjections. The hon, member for Burin-Burgeo—

Mr. Simmons: Get it right.

Mr. Clark: —who shouts from someone else's seat, has not been heard to speak about the impact upon fish plants and upon unemployment in the province of Newfoundland. If he believed as much in his duty to his constituents as he believes in his blind loyalty to the Liberal Party, he would be standing and voting against that budget!

The Acting Speaker (Mr. Ethier): The hon. parliamentary secretary on a point of order, and it will have to be on a point of order.
