## WAYS AND MEANS

## TABLING OF NOTICES OF MOTIONS

**Hon. Pierres Bussières (Minister of State (Finance)):** Mr. Speaker, as I explained briefly this afternoon, I ask the unanimous consent of the House to table two notices of ways and means motions, one concerning the Excise Tax Act and the other Excise Act. I have already indicated that this is necessary because we want to amend the provision concerning the quarterly indexation for tobacco and alcoholic beverages to provide for a yearly indexation. My explanations failed to convince the hon. member for Edmonton West (Mr. Lambert), and he was quite right since the tabling of a ways and means motion is justified if the period over which the indexation will apply is being changed, thus bringing about a change in revenue. As I said, I failed to convince the hon. member this afternoon, but following our discussions and after examining this provision concerning the new period, the hon. member for Edmonton West informed me that a ways and means motion was required to make such a change.

Therefore, Mr. Speaker, with the unanimous consent of the House, I shall now table the two ways and means motions and ask the House to approve them. I shall also ask the unanimous consent of the House to table the amendments related to these ways and means motions, namely three amendments which will provide for a yearly indexation instead of a quarterly indexation. I wish to thank the hon. members for their excellent co-operation.

**Mr. Deputy Speaker:** The minister asks the unanimous consent of the House to table two ways and means motions. Is there unanimous consent?

**Some hon. Members:** Agreed.

## THE EXCISE ACT (2)

**Hon. Pierre Bussières (Minister of State (Finance))** moved:

That a Ways and Means Motion to amend the Excise Act, notice of which was tabled in the House on Tuesday, May 26, 1981, be concurred in.

## THE EXCISE ACT (3)

**Mr. Bussières:** Mr. Speaker, of course, the three amendments Nos. 8, 13 and 58 already tabled are automatically withdrawn and replaced by the three amendments I have just tabled.

**Mr. Lambert:** Mr. Speaker, may I suggest that perhaps the substituted amendments could occupy the same numerical positions as the original amendments because they fall into sequence as to, shall we say, the "logicality" of the debate. We are quite in agreement with that.

**Mr. Deputy Speaker:** In order to have it clear, there is, first, unanimous consent respecting the two ways and means motions of the minister, and then two amendments will be withdrawn, but the same numerical sequence will be followed.

**Mr. Knowles:** Three others.

**Mr. Deputy Speaker:** Three others will be withdrawn, but there will be the same numerical sequence for the new material. Is that agreed?

**Some hon. Members:** Agreed.

**Mr. Deputy Speaker:** It is so ordered.
