Mr. Speaker: I thank the hon. member for his intervention. That has been a clear and concise explanation of why this is being asked. We have a situation at this point where the government has completely and utterly acceded to the request of the New Democratic Party.

The Hon. Member for Ottawa-Vanier has the floor.

Mr. Gauthier: In talking to the procedural aspect of this question, I could give the House a brief explanation as to how to proceed with private bills and how members file petitions. I could read document after document into the record as to the difficulty with the standing order and other information that I have. I hesitate to do so because I think the Speaker would show his impatience with me.

My only comment is that, indeed, we are upset and believe that the government should have presented a global comprehensive approach to transportation before going ahead with the VIA Rail cuts, and the savaging of railroad transportation services. But we would certainly give unanimous approval that this matter be referred to the appropriate committee for consideration at this time.
