1893. Summer Arrangement. 1893

On and after Monday, the 26th June, 1893, through Express Passenger trains will run daily (Sunday excepted) as follows:

Table listing train routes and schedules: Levee Montreal by Grand Trunk Railway, Levee Montreal by Canadian Pacific Railway, Levee Montreal by Canadian Pacific R'y from Dalhousie Square Depot, Levee Levis, Arrive Riviere du Loup, Trois Plateaux, Rimouski, Ste.
