Has the Minister of Transport looked into the report made on CBC programme, "Cross Country Check-up," on Sunday, November 14, 1976, by a caller, that a DOT JetStar had landed at Saskatoon Airport with five female passengers on the same day that the Minister himself arrived at the same airport on another DOT JetStar and (a) if not, on what date will he do so (b) if so, what are full details involved including (i) names, addresses and job designations of all passengers involved (ii) purpose of their visit to Saskatoon (iii) reasons for use of the government aircraft (iv) point of departure and point of arrival of all flights made (v) total cost to the taxpayer (vi) name and job designation of the highest ranking person authorizing the use of the aircraft?

Hon. Otto E. Lang (Minister of Transport): Yes. (a) Not applicable. (b) (i), (ii), (iii), (v) and (vi) The aircraft was assigned to the Minister of State (Fitness and Amateur Sport) who was using it on official government business.
