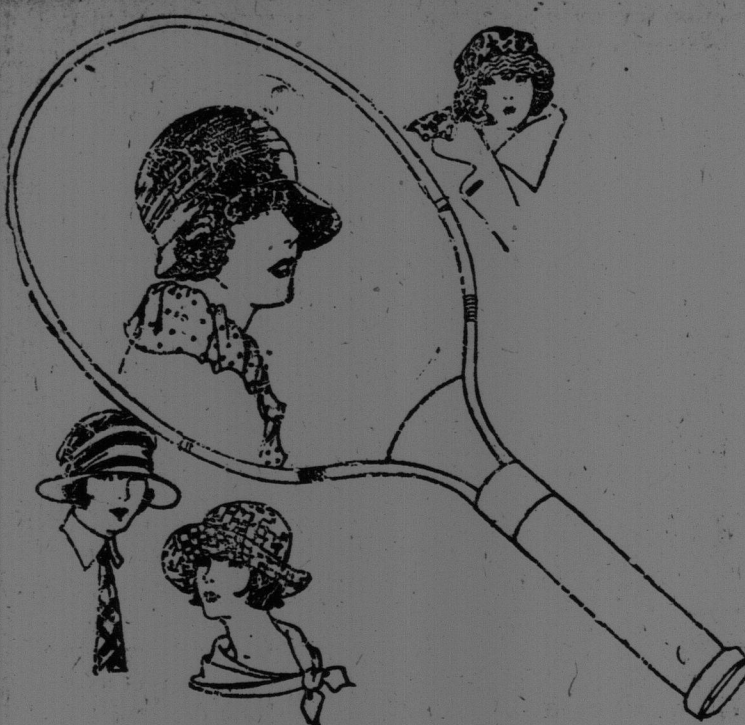

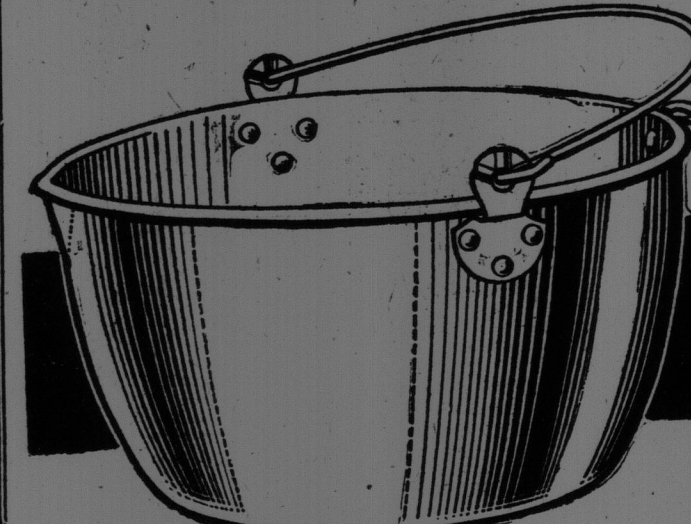

WILL TAKE PLACE OF THE BUG LIGHT

Tug John C. Stoneman to be Placed at Station—Mrs. Frank F. Ross Dead.

(Special to Times)—Yarmouth, N. S., June 30.—The government tug John C. Stoneman, Capt. Loran A. Kenney, has arrived from St. John after repairs. She has a great quantity of work to do, including placing a new bell at Cat Rock, replacing bell buoys at Yarmouth Southwest fairway, Peace's Island fairway and Gannet dry ledge, also a new gas buoy for the Public fairway. New buoys will also be placed in Cockatw Pass, where necessary. The tug will be supplied with coal and oil for the various fog alarm stations. The tug John C. Stoneman will also be placed in position as a temporary ship, replacing the Bug Light, which is to be dismantled.

The department of Marine and Fisheries has chartered the C. Stoneman to the Yarmouth Salvage Company and the tug has been converted into a light and bell boat. A light will be carried at the mast head and a bell installed over the pilot house. This will be sounded in foggy weather similar to that of the Beaco Light.

Two men were arrested at Port Maitland yesterday by Constable McMillan, charged with stealing several hundred pounds of live lobsters from the Neville Canneries. They pleaded not guilty before stipendiary Pelton and will come up for trial July 13.

The Woods Harbor schooner Eliza Goreham has finished loading 79,375 feet of lumber and 41,000 lbs. The cargo was supplied by Parker Company for Boston.

Mrs. Nellie Ross, wife of Frank F. Ross, formerly of Yarmouth, passed away. She had been in indifferent health for the last few years, suffering from a weak heart. She leaves her husband and two sons, Albert and Francis, also one sister, Mrs. Josephine Morrison. The body was taken to Letich's Creek near Sydney, N. S., her former home.

VOTE TO DISMISS HALIFAX OFFICIAL

Fifteen to Five in Council for Discharge of City Collector—May be Criminal Proceedings.

Halifax, N. S., June 30.—The City Council voted last night, 15 to 5, to dismiss City Collector Robert Theakston and to institute civil proceedings for recovery of money, "for which he is accountable to the city," and further to institute criminal proceedings involving him in an embezzlement charge.

City Collector Theakston has held his position for thirty years and was recently suspended as the result of investigations conducted by special auditors. The auditors reported that sums of money for which receipts had been issued, including \$23,000 paid by two taxpayers, were not credited to them in the city books.

Rotary Convention Was Big Success

Dr. H. L. Spangler Home—Delegates 8,000—Canadian Appointees.

Dr. H. L. Spangler returned to the city yesterday after attending the International Rotary Conference in St. Louis, Mo. More than 8,000 delegates from all over the world attended the conference, twenty-one nations being represented. In spite of the mixture of nationalities everything went smoothly and the conference was a marked success from every standpoint.

No meeting place for next year has as yet been officially announced but it may be Toronto, Mexico City is making a strong bid for it.

Canadians who figured in this year's conference were Dr. MacInnes of Dalhousie University who was appointed to the National Advisory Board for Canada; John Gibbon of Toronto, who was appointed to the International Board of Directors; and Dr. Spangler who was appointed district governor of Rotary District 32 which includes the Maritime Provinces, Newfoundland and Eastern Quebec.

Dr. Spangler reported a very pleasant trip. On the way home the delegates had a special car from St. Louis to Chicago. They took the steamer at Chicago for Buffalo. From there they motored to Niagara Falls, Ont., where they entrained for home by C. N. R.

Portland Men to Fete Premier King

Function Planned for September 2 Somewhere Between Ottawa and Montreal.

Portland, Me., June 30.—The members of the Portland-to-Portland party, who will leave on a state chamber of commerce special train for Ottawa and the Pacific coast, plan to entertain Premier Mackenzie King and other Canadian officials on the outgoing trip. It is intended to make a three-hour stop at some point designated by the Premier between Montreal and Ottawa, where the function will be held.

Governors and mayors of Washington, California, Nevada, Utah, Colorado, Kansas, Missouri, Illinois, Indiana and Michigan will be invited as special guests of the party at luncheons, dinners and other events when the west is reached. Sixty-five men and women have signed for the trip and indications are that 140, the limit to be accommodated, will make the journey, which terminates in this city Sept. 25. The coast-to-coast trip is being taken for the purpose of advertising Maine's resources and attractions and to learn what the west is doing.

Thugs on Warpath Inside a Garage

Bind 4 Employees and Smash Cars With Pistol Butts When Truck's Engine Balks and It's 'Silk' Cargo Proves Paper.

New York, June 30.—Three sturdy bandits entered the Madison Square Garage, 155 East Twenty-fourth street, and, failing to find a truckload of silk they had consigned there, smashed the machinery and fittings of three automobiles, after tying up two washers and two chauffeurs.

They had had luck all around in what was evidently a carefully laid plan. In the first place, the rolls on the truck which the robbers thought were silk were only wrapping paper. They decided to take the truck instead. The truck, however, had just been washed, the magnets were damp and the engine balked.

The bandits flew into a rage, tore off the hood and belabored the engine with the butts of their revolvers. After tearing loose everything they could they picked up some tools from a work bench and got busy on two touring cars, scattering pieces of them all over the garage.

The whole proceeding went on to an accompaniment of about profanity which could be heard in the street. One of the chauffeurs, overcome with the humor of the situation, tittered.

"It'll like the same to you," one of the bandits growled at him, indicating the dismantled engine of the truck.

With this parting shot the three departed, closing the door behind them.

THIRTEEN CASES NEXT WEEK IN DIVORCE COURT

Four New Ones Are From St. John City.

Court to Sit in Fredericton on Next Tuesday, and at Once Adjourn Until July 5, Because of Visit of the Governor-General.

(Special to 'The Times'). Fredericton, N. B., June 30.—The New Brunswick divorce court will meet on next Tuesday morning but will adjourn at once until the fifth as the official visit of His Excellency the Governor-General will be on the third. Nine cases are filed and three unfinished cases are for further hearing. In addition, one remanent also is to be heard. The total of thirteen cases is larger than ordinarily. Only one of the number can be termed a post bellum case, the defendant having been married in London during the war.

The unfinished cases are those of George E. Logan vs. Rebecca Logan; Hugh J. Stairs vs. Mildred Stairs; and Anna Bell Steeves vs. Frank Joseph Steeves. Logan vs. Logan was tried previously, but was left open for the production of more evidence. New witnesses have been subpoenaed in it. The plaintiff resides in Fredericton and the defendant in Devon. Stairs vs. Stairs was left open for the additional evidence relative to the marriage. Both parties belong to Woodstock. Steeves vs. Steeves is a Moncton case. Additional evidence of infidelity was required.

Charles Kelshaw vs. Ethelred Kelshaw is an Albert County case, the plaintiff residing at Coveville. They were married in England in 1902 and in 1910 removed to Moncton. Ethelred Kelshaw is named as co-respondent. Desertion and infidelity are alleged. T. T. Goodwin is proctor.

Stella May Mills vs. Harry Weeden Mills is a Moncton case, T. T. Goodwin proctor. The plaintiff lives in that city; her maiden name was Gallant. Opelia A. Fitzpatrick, Methodist, married them in Moncton in 1916 and they lived together till December of the year following. The husband then went to Halifax to seek employment and it is alleged that after a time he stopped writing to his wife. She went to Halifax and was told her husband had left for parts unknown. No children were born of the marriage. In 1922 the plaintiff learned he was in St. John. Mary M. Comeau is mentioned as co-respondent. Statutory grounds are alleged.

Lesette Gertrude Taylor vs. James Taylor is a Moncton case, the plaintiff residing in that city and the defendant at Hancock, Mass. A. A. Allen is proctor. The defendant prior to marriage by Rev. H. L. James at St. Dunstan's in the West, London, England, Church of England clergyman, was named Petrie.

On December 19, 1918, while the defendant was on leave from France where he was serving, they were married. In January, 1919, the defendant embarked for Canada. The plaintiff corresponded with him at Berlin, N. H., and with her mother in December, 1919, joined her sister, Mrs. Jeremiah Dale at Moncton. Infidelity by the defendant is alleged.

Isabelle Bramen vs. Thomas Abner Bramen is a St. John case, both residing in that city. M. B. Innes is proctor. The maiden name of the plaintiff was Andrews, and she was married to defendant at St. John by Rev. Gideon Swin, Baptist, on July 21, 1900. Alice Vaughan is named as co-respondent, and is said to be passing as his wife now.

Gordon Robert Stevens vs. Mary Regina Stevens is a St. John case, both parties living there. Rev. T. A. Blackadar, Baptist, married the defendant and her mother in Nova Scotia and St. John. In 1919 they separated. Edward J. Garnett of St. John is named as co-respondent, it being alleged the defendant is living with him as his wife. C. F. Inches, K. C., is proctor.

Archibald Melrose Halliday vs. Mary Wilson Halliday is a St. John case, both residing there. J. Stur Tail is proctor. They were married January 13, 1907, at St. John by Rev. W. O. Raymond, Church of England. Their children were born in James Moses of St. John is named as co-respondent and infidelity with other men is alleged.

Isabella Call vs. George Call is a Kent County case, the plaintiff residing in Walsford and the defendant in Harcourt. G. A. Hutchinson is proctor. The maiden name of the plaintiff was Agnew and they were married by Rev. J. B. Young, Methodist, in August 4th, 1906. Cruelty and neglect are alleged, the wife finally returning to her parents' home in October, 1908. Annie McLary of Walsford is named co-respondent.

Thomas Kenneth Raymond vs. Katherine Christine Raymond is a St. John case. George L. Harris is proctor. The defendant was named MacDonald prior to marriage. Rev. Ralph J. Houghton, Congregationalist clergyman, married them in St. John on September 10, 1915. It is charged that the wife later left her husband and since has lived in Montreal and Ottawa. Adultery by persons unknown is alleged. A daughter was born of the marriage.

Martilla M. Rabineau vs. Joseph Babineau is an Albert County case. Teed and Teed are proctors. The plaintiff, under the maiden name of Beechin, and the defendant were married November 24, 1897 by Rev. I. B. Colwell, at Hopewell. They made their home at Curryville Albert County. One son was born.
