#### Important Legislation Likely to Be Introduced at the Coming Session of Legislature.

Toronto, Ontario, January 9,—
The government is considering the
advisability of a system of inspection of loan companies, particularly
of the companies which, like the
York County Loan & Savings Compeny, issue terminating shares. At
the present time there is no inspection in the actual sense of the
word. The act requires that annual statements of the business of
loan companies, sworn to by the
President and Secretary of the concerns, shall be supplied to the Registrar of Loan Corporations, who
publishes them in his annual report,
while the information demanded under the act for this purpose is more
detailed and complete than is called
for by any other country or State
ian the world, the solvency of the
companies is not guaranteed. The
Government assumes no responsibility beyond publishing the returns
and moving against parties showa

It has been felt for some time, however, that a system of inspection of the books and papers of conterns making such returns should be carried out by an official appointed by the Government, the latter thus assuming responsibility for their correctness. The difficulties in the way are recognized, but the responsibility of the Government to the public is also clearly felt, and it is hoped that a plan can be adopted which will safeguard the insterests of all concerned.

In connection with this plan the idea of some method of investigating the bona fides of industrial concerns proposing to ask the public to subscribe for stock, before charters of incorporation are issued by the government, has also been discussed. This also is a big problem, and it is not easy to decide just what can be done. There is good reason to believe, however, that important measures, relative to loan and industrial company inspection will be introduced at the next session of the Legislature.

#### AGED MINISTER'S PLUCK

DEFENDS HIS HOUSEHOLD WITH PITCHFORK.

Belleville, Jan. 9.—Rev. Dr. Gardiner, 89 years of age, one of the oldest Methodist ministers in Canada, this morning at two o'clock drove away an intruder who was attempting to enter his residence. The visitor broke in the glass front door, and the noise awoke the doctor's wife. The old gentleman went down stairs and found the man endeavoring to unlock the door. He grabbed a pitchfork and struck the man. Superintendent H. F. Gardiner of the Institute for the Blind at Brantford is a son and Miss Ella Gardiner, preceptress at Albert College is a daughter of the heroic clergyman. It developed later that the intruder was a neighbor, named John Pepper, who thought he was cantering his own house. He shows signs of severe handling and has deep wounds in his arms, made by the pitchfork.

#### **VERDICTS FOR \$1,500**

AGAINST THE LONDON STREET RAILWAY CO.

London, Jan. 10.—At the Winter Assizes, before Chief Justice Meredith, in the case of Kert vs. London Street Railway, the jury found a verdict for plaintiff. This suit was brought by James Kerr of Maitland street on account of injuries received by his twelve-year-old son who was run over by a trolley car at the corner of Maitland and Dundas Sts., losing a log in consequence of his injuries. The suit was for \$10,000 and costs, but the jury awarded \$1,250 to the hoy and \$250 to the father. A stay of thirty days was granted.

Novel Scheme to Prevent Corruption In Kingston.

NO CARRIAGES FOR VOTERS

Contestants Draw Up Unique Agree ment Involving 300 Voters-Member Elected In Bye-Election Will Resign Seat If Board of Referees Finds Corruption on the Part of the Stated Workers.

Kingston Jan. 10.—This city has acquired an unenviable notoriety in connection with bribery and corruption in elections, but a better day would seem to have now dawned. Yesterday a document was signed by the leaders, whose contents, if loyally observed, will on the 25th secure purity where impurity has reigned.

The memorandum of agreement, made the 9th day of January, between the candidates undersigned, and their respective agents and supporters, witnesseth that, whereas it appears that nesseth that, whereas it appears that improper practices have prevailed in recent elections in this city, and both political parties are desirous of preventing any recurrence of the same, and that both the letter and the spirit of the Election Act should be strictly observed in the impending election, they mutually agree, as a matter of honor and good faith, to do all they can to avoid any violation of the law; therefore to that end it is mutually agreed as follows:

1. The agreement shall be signed by

agreed as follows:

1. The agreement shall be signed by each candidate, and at least 150 of his supporters, who shall be selected and named in writing, by or on behalf of the opposite candidate. When satisfacterily signed, it shall be marked "approved" by each candidate and then become operative.

2. The supporters of each candidate who sign the agreement are acknowledged by each candidate as his agents within the meaning of the Ontario Election Act, for the purposes of this election.

3. The parties signing bind them selves in honor and good faith to abso selves in honor and good faith to absolutely refrain from and prevent, as far as they can, any infraction of the Ontario election law, among which infractions are: (a) The bribing of voters by money or other valuable consideration or promises. (b) The procurring or promising of office, place or employment for voters or unduly influencing them. (c) The subscribing, advancing or paying money for the purposes of the election, except the money bona fide paid into the hands of the financial agent of the candidate, such agent to keep an accurate account thereof, open to the inspection of any party signing the agreement. (d) The corruptly treating or furnishing entertainment to voters. (e) The corruptly betting or wagering on the election. (f) The hiring of vehicles to convey electors to the polis or the paying of the traveling expenses of voters. (g) The personation of voters. lutely refrain from and prevent, as fa

of voters. (g) The personation of voters.

4. The parties to the agreement undertake that they will not be guilty of or privy to any such infraction in respect of the election.

It is further agreed that to prevent any doubts as to the observance of the law, no vehicles shall be hired, asked to be volunteered, or used be volunteered, volunteered or either in connection with the registration of voters, to take persons up t

either in connection with the registration of voters, to take persons up to register, or on election day to take voters to the polls to vote. Each candidate is, however, allowed to have one vehicle on election day for his personal use, which he may also employ to transfer his workers from one poll to another to work, but not to vote.

For the purpose of enforcing the provisions of this understanding, it is agreed that Bishop Mills, R. V. Rogers, K. C., and J. L. Whiting K. C., shall be a tribunal, with full power to inquire into and determine all cases of alleged violation of the agreement. They shall have power to call before them any party to the agreement, and obtain any other evidence they may be able. They may employ a stenographer to take any evidence by statutory declaration, if they see fit. If at any time, upon information furnished within 38 days of the election, said tribunal shall, upon inquiry, find that there has been a breach of this agreement, directly or indirectly, by or with the knowledge, consent or connivance of any person a party to this agreement, then the candidate of whom such person is admitted and declared to be an agent, shall, if successful at the byelection, forthwith resign his seat.

Old Council Divided on Payment of S. G. McKay's Account re the Mandamus Proceedings

Vote of Thanks Tendered the Retiring Councillors-Accounts Passed.

The councils for the years 1905 and 1906 met in the council chamber this morning. The 1905 council met at 10 o'clock and passed a number of accounts. A vote of thanks was passed to the retiring members of the council and speeches were made by Mayor Boles and all the members of the council.

All the members of the council for 1905 were present, as follows: Mayor Boles, Ald. Coleridge, Coulter, Fleet. Mills, George and Johnston. The minutes of the last special meeting were read and confirmed.

The following accounts were read and ordered to be paid:

Ald. Mills asked for the yeas and mays on the original motion and it was carried on the same division.

In speaking to the resolution Ald. Coleridge said he did not want to be considered an obstructionist, but he wished to put the ratepayers right in connection with the account. After the judgment was given by Sir William Meredith against Mayor Boles, and ordering him to pay the costs the bills were presented and paid by His Worship. This account was made up of costs which could not be charged to the Mayor and should be paid by the three plaintiffs in the case, viz.: the corporation, the Gas Co., and the private citizen, While in Woodstock he had asked Mr. McKey to divide his account into three parts, but the solicitor had stated that he received no instructions from either the Gas Co. or Mr. Kennedy, His instructions had all been given by the aldermen and he had no one else to look to but the corporation for payment of his account.

Ald, Coulter remarked that the ac-

Ald, Coulter remarked that the account covered not only the corpora-tion's costs but also the costs of pri-vate individuals. In his opinion the council should pay only part of the

account.

Mayor Boles took strong objection to the payment of the account. There were items in the bill which should not be there, Five dollars was charged for coming to Ingersoll to see if the contracts were signed, when they had been signed before the solicitor left Woodstock, He had paid an account of over \$115 to Mr. McKay and he thought that included all his costs. Ald. Coulter and Coleridge moved

Ald, Coulter and Coleridge moved the amendment as above but it was lost and the original motion passed. Moved by J. B. Coleridge, seconded by Mayer Boles, that a vote of thanks be passed and extended to the retiring members of the council for the services they have rendered the town during their term of office.—Carried.

Difference of opinion had been fought out in a business-like way and the most pleasant thing in connection with the council was that after questions had been discussed and settled no ill-feeling had been aroused. All the aldermen were as good friends personally as they had been at the beginning of the year.

#### **UP GOES LUMBER**

B. C. COAST. MILL OPERATORS WANT HIGHER PRICES.

Vancouver, Jan. 9.—Owing to the great scarcity of logs, and the consequent high prices at which they are held, it is positively assured that in the next few days an advance will be declared in the price of all grades of lumber. This statement was made this morning by a mill man who is thoroughly conversant with the present situation, and is in close touch with the leaders of the local association. The action, when it is taken will be a concerted one and the members are determined to stand by the new figures. Just when the new scale would go into operation, and how much the advance would be could not be definitely stated. The situation was being thoroughly looked over before action was taken.

Last week a new scale for shingles was established by the local association. The increase was fifteen cents which restores shingles to their old price of \$1.85. The sole reason given by the mill men for their action in that the advance of the price of logs renders it impossible to turn out shingles at the reduced rate except at a loss. There is said to be very little demand at present hence the rise in price will arouse little comment.
