His Decision Announced at a Third Ward Meeting.

Set-To Between the Other Candidates-A Big Crowd and a Noisy Gathering in Hamilton Road

The first meeting of the electors of No. 3 ward was held in the Hamilton road school house last night. It was probably the most boisterous and largely attended meeting ever held in that division of the city, being especially noisy during the speeches of Mayor Essery and ex-Mayor Taylor. The sensation of the evening was the withdrawal from the mayoralty contest of Mr. Geo. T. Hiscox, which was announced by himself at the conclusion of his address. Mr. Hiscox said that he had entered the field only as an independent candidate. Rumors had been spread by some persons in regard to himself, and he had challenged any person to prove their truth. The meeting in St. George's school house, he said, was a disgrace, and he did not consider it an honor to be in the field with the other candidates, and had decided to withdraw from the contest, thanking his mover and seconder.

Before any of the candidates spoke Mr Before any of the candidates apoke Mr. Joseph T. Marks asked them whether or not they were in favor of the 60-hour clause in the street railway agreement. He said that when the company began to dicker for an electric franchise it was time the 60-hour clause was looked after.

All the candidates were in favor of the clause.

CHIC-20, Dec. 29.—In the Prendergast trial to-day at 1:25 p.m. the case was given to the jury, who returned into court at 2:28 p.m. with a verdict of guilty, and recommended that the prisoner be hanged. There was no scene in ecurt when the verdict was amounced. The prisoner uttered not a word and seemed to betray no feeling of anxiety.

After Prendergast had been removed from the court room, Attorney Wade entered a formal motion for a new trial, which will be urged next week.

Jailer Morris removed the condemned man to-night to the "murderers' row, and sent word that he would not see any visitors, newspaper men especially.

New York, Dec. 29.—Bradistreet's says there are 1,781 business failures reported in the Dominion and Newfoundland in 1893 compared with 1,682 in 1892, with liabilities amounting to \$15,690,000, about 50 per cent. more than in the year before, and assets \$7,388,600, a proportionate increase compared with the year before.
