The cautious American ventured to suggest that possibly the sage of Birmingham had overdone it, and the revolt against Radicalism might prove so strong that the Tories no longer would have use for their Lib-eral-Unionist allies. Mr. Chamberlain smiled the knowing smile of the man who is absolutely sure of his position and replied: "That is impossible. We shall obtain a working Unionist majority in the new Parliament, but the

VICTORY FOR THE TORONTO RAILWAY.

London, July 20 .- The Privy Council has granted the Toronto Railway special leave to appeal from the decision of the Supreme Court of Canada, which dismissed the appellants' action to recover the amount paid for customs dues levied on steel rails.

ALBERT EDWARD AT THE RACES. Berlin, July 21.-The Prince of Wales is coming to Baden-Baden to attend the races as the guest of Prince Fuerstenburg. The Crown Prince of Greece, who is now the guest of ex-Empress Frederick at Kronburg, Prince George of Prussia, and a host of German and foreign aristocrats are expected to be present at the Baden-Baden races.

THE PORTE AND ARMENIA. Constantinople, July 21.-The Porte has appointed Shakir Pasha to supervise the reforms in Armenia. This is regarded as a concession to the powers, which are still asking for a more definite statement as to what reforms the Porte proposes to carry out.

AN AWFUL DISASTER. Spezzio, Italy, July 21.-A terrible accident occurred near the mouth of the Gulf of Spezzia today, the steamers Ortigia and Maria P. ran into each other, and the latter was so badly damaged that she sank in a very short time. She had on board, in addition to her crew, 141 pasengers from Naples, all of whom were drowned. The scene on board the sinking steamer defles description. The passengers were panic-stricken and rushed hither and thither calling on the saints to save them. The steamer, it is said, filled so rapidly that it was impossible to cast free and launch the small boats on

board of her or on the Ortigia.

A later dispatch says the accident resulted in the loss of 148 lives today The Maria P. had on board, in addition to her crew, 178 passengers bound from Naples for the River Plate, by far the larger part of whom were immigrants. The night was pitch dark when the collision occurred and most of the passengers were asleep in the bunks at the time. From the reports received here it is impossible to determine whether any attempt was made by the Maria P to launch her small boats, but judging from the accounts given by the excited survivors it is surmised that the steamer went down too quickly to allow of this being done, though one boat got away.

The blackness of the night added

to the terror of those on board, and it is added that some passengers, crazed with fear, jumped overboard. he Ortiga on her previous voyage

collided in the same spot with a French steamer, and this fact adds strength to the belief hat she was responsible for this morning's disaster.

The Maria P. was a schooner-rigged iron screw steamer of 772 tons gross and 420 net tons. She was built in Sunderland in 1886, and was 175 feet long, 27 feet 1 inch beam and 19 feet 8 inches in depth of hold. She had five compartments. She was owned by Marini Brichetto and her hailing port was Genoa.

STAMBULOFF'S SENSATIONAL FUNERAL.

Sofia, July 20.-The funeral procession of M. Stambuloff started at 2 o'clock for the cathedral, where services were held. M. Stambuloff's mother and M. Petkoff, a political friend, followed the hearse. There were present all the foreign envoys with the exception of the representa-tive of Belgium and 200 friends of the deceased. When the scene of the assassination was reached the procession halted and M. Petkoff delivered an harangue. Suddenly a revolver was fired and somebody cried, "Run for your lives." The onlookers were panicstricken and rushed in all directions. Mounted gendarmes hurried up and quiet was restored. The diplomats withdrew and the gendarmes escorted the remains to the cathedral. When the mourners and the others arrived at the cemetery they met an organized crowd of the friends of Major Panitza, who was accused of treason. This crowd had decked the graves of Major Panitza and his accomplices with flowers and Bulgarian flags. They barred the passage of the hearse containing the remains of M. Stambuloff and threatened those accompanying it. A detachment of cavalry that was posted at the cemetery surrounded the two parties. The coffin was lowered into the the grave in silence. Very few of the mourners reached the grave. The city was much excited.

many surprises of this very surprising contest. Everybody thought he would be thrown out, and Mr. Balfour went out of his way to incite his constituents against him, in order to make assurance doubly sure. Sir Matthew White Ridley was placed in an office pending his election to the Speakership and a coveted Secretaryship of State was to be given one of the disappointed Tories who were left out of the Cabinet. Mr. Gully knew all this, and made a desperate and successful fight in Carlisle. Now he has to be reckoned with. The probabilities are that Mr. Balfour will endeavor to avoid a party division over the Speakership by giving Mr. Gully a judgeship or sending him to the House of Peers as a new lord. Mr. Gully is not likely to raise any difficulties in the way of this arrangement, although naturally he will prefer to retain the Speakership. He stands to gain, anyhow, because if he should be rejected by the Commons, and he should get nothing else, he would be entitled to a pension of £5,000 a year as ex-Speaker.

PAN-AMERICAN CONCRESS.

The "Settlement" Idea Explained by Miss Adams.

The Church in Modern Life"-Movements for Enlarged and Purer Womanhood.

Toronto, July 21.-Rev. Dr. Burns, of Hamilton, occupied the chair at the Pan-American Congress yesterday morning. Miss Jane Adams, of Hull House, Chicago, delivered an address upon the settlement idea. She explained that the term means a group cf persons in good circumstances who settled in an industrial and depressed district in a city and exert there all the good they can. She denied that the institution with which she is connected is a center of socialism or a single tax propaganda and gave a vivid description of the crowded neighborhood where she works, of efforts to make the neglected people feel that they are part of human Christian brotherhood, and of attempt to remedy the odious sweating system by co-operation and shortening of the hours of labor.

Rev. Dr. Morgan Wood, of Detroit, delivered an animated and vigorous address on "The Church in Modern Life." He was heart and soul for the direction of Christian effort to social conditions.

Mrs. S. G. Wood, Dominion president of the Girls' Friendly Societies, closed the programme with an interesting sketch of the movement for an enlarged and purer womanhood, with which she has so long been identified. Sectional meetings were held in the Metropolitan Methodist Church and St. James' Square Presbyterian Church in

At the evening session of the congress the programme was carried fully with the addition of an address from Rev. Father Ryan, rector of St. Michael's Cathedral, on "Organization of Charity and the Catholic Church." His remarks were characterized by the widest charity.

The next speaker was Mrs. Henry Wade Rogers, of Evanston, Ill., who spoke on the subject of "Recent Progress in Philanthropy." Her paper was a general review of the rise and development of our Christian institutions for the relief of suffering.

"The Scientific Value of Love" was the subject handled by Prof. William Tremont Blackman, of Yale University. He argued that love was the central thought of all religion, and that the forces of love had always existed under conditions of barbarism.

MRS. HOLMES MAY TURN. Indianapolis, Ind., July 22.—Mrs. Holmes, the wife of the accused murderer and insurance swindler, left here for Philadelphia yesterday at the instance of the prosecuting attorney of that city. Mrs. Holmes herself would not talk, but her most intimate friend, to whom she confided her purpose, did talk last night. This person says that Mrs. Holmes has forsaken her husband. This person was told by Mrs. Holmes that the assertion of Holmes that he was not in Toronto, but was absent with his wife when the Pietzel children disappeared, is not true; that wherever Holmes was at that time, he was not with Mrs. Holmes. Moreover, Mrs. Holmes says she was with Holmes in Chicago at the time Miss Williams disappeared. Somebody Disappointed—The Hudson Bay Railway Bill Introduced at the Last Hour.—An Important Clause Clipped off-The Bill Itself Nearly Strangled in the Senate-Prorogation Postponed Until Monday.

Ottawa, July 21.—When the Commons resumed at 3 o'clock, on the motion for the second reading of the Hudson Bay Railway bill, Mr. Mills, of Bothwell, took the point of order that a bill amending a private bill could not be introduced as a Government measure. Mr. Martin dwelt on the change of route which left Winnipeg out and sub-stituted Gladstone, and contended that the Manitoba Government ought to have had an opportunity of appearing if they chose and saying how far their interests were affected, if any. Mr. Tupper and Mr. Daly opposed the point of order, but the Speaker held it

was good and ruled out section 3 au-thorizing the change of route, and this section was consequently struck out. This left the bill authorizing the dividing up of the subsidy and \$80,000 a year for twenty years in two halves. one for each half of the road, and extending the time for completion until 18:8-three years from now.

Mr. Laurier offered an amendment depriving the company of the subsidy If they ceased to operate the road. This was lost, and the bill passed and went to the Senate at 4:15 p.m.

Here Mr. McInnes, a Hamilton Con-servative, moved the three months' heist, and it is said it would have carried then, a majority of the senators being against the bill, but a debate ensued, Mr. Scott supporting the hoist. He said it was reported, but he would not believe truly, that the proposed loan of \$2,500,000 was to have been shared by the Government for election purposes.

Premier Bowell sprang up and in-dignantly repudiated any such bood-ling, and characterized Mr. Scott strongly for daring to mention it. At 5:30, the hour his Excellency had

set for proroguing Parliament, the debate was still in progress, and the Ministers from the House of Commons came over, and a sort of Cabinet council was held in the cloak room. A message was sent to Rideau Hall asking the Governor-General not to come until 6 o'clock. The military officers, aides, guards of honor, general public, all the accessories of prorogation, were on hand At 6 o'clock Premier Bowell, who was

very much put out, announced that the Government had decided not to prorogue, and the soldiers and citizens went away feeling that they had been fooled. Never before has prorogation been deferred after it was once officially announced.

The Senate met again in the evening, and after further debate Senator Mc-Innes' hoist was defeated by 7 to 11, only eighteen senators voting. A few absented themselves. The motion for the first reading carried, and the second reading will be moved at 10 o'clock

Mr. Van Horne and Judge Clarke, of the C. P. R., were around, evidently interested in the fate of the bill, but it is generally felt that the bill is now of little use to the promotors. The fact that the Government delayed introducing it until the last day of the session-about seven hours before prorogation-when they knew it could be killed in half a dozen different ways, rather goes to show that they were not particular about it.

Hon. Wilfrid Laurier in the Commons said he would not delay the bill and did not, and Premier Bowell made an acknowledgment of this in the debate. The Commons will meet again at 10 o'clock tomorrow.

REMENYI IN COURT.

Played on a Violin and Swore It Was Not a Strad.

New York, July 22.-Edouard Remenyi, the famous violinist, was one of the witnesses in the Bott-Flechter Stradivarius case in New York. A socalled Strad violin had been stolen from Mrs. Bott. The State was trying to prove that a violin claimed by Flechter, defendant, was the identical fiddle. Hence the importance of Remenyi's testimony. When called Remenyi came forward and said he was nervous and didn't want to play.

"What is the good?" he said; "it will show very little. I can take a violin that is worth \$4 and make it mellow or harsh, just as I wish. It is the player more than the fiddle that counts.' "Well, before you play I want to ask you a few questions," said Mr. Flecher's lawyer. "How long have you been playing the violin?" "Fifty years."

"And in that time how many instruments have you played on?" "About 10,000; maybe more."

"Could you tell a Stradivarius from any other kind of violin?" Remenyi grunted. "Could you tell black man from a white one?" he asked in return. "I could not be mis-taken," he added.

"Is this a 'Strad?' " asked the lawyer, handing the instrument to the old musician. "No." snorted Remenvi.

The old man then took the instrunent, at the request of the lawyer, and played a selection from "The Huguenots." At the conclusion of the playing the court ordered an adjourn-
