

And also,—Return to an Order of the House of the 9th March, 1932, for a Return showing:—

1. How much excise tax per pound is collected on domestic raw leaf tobacco when used in licensed factories in Canada, and how and when the tax is collected.
2. Amount collected for the fiscal years ending March 31, 1930 and 1931.
3. Total amount of tobacco consumed in Canada each year from 1908 to 1931, inclusive.
4. Tobacco grown in Canada during the years 1908 to 1931, inclusive.
5. Tobacco imported into Canada in the above years, and from what source were the said imports.
6. Tobacco exported from Canada during the above years, and to what countries.
7. What rebate of import duty is allowed on imported raw leaf when manufactured for export purposes.
8. What bonding privileges are extended to licensed manufacturers when raw leaf tobacco is imported by them.
9. How much imported raw leaf tobacco was used for export purposes during the years 1908 to 1931, inclusive.
10. Average prices received by the tobacco growers of Canada: (a) for their 1929 crop; (b) 1930 crop, and (c) 1931 crop.
11. How the departmental officials arrive at the average price paid for tobacco in the United States.
12. Whether the Canadian Government classifies the different types of tobacco raised in Canada, imported into Canada and exported from Canada.
13. If not, for what reason.

Mr. Sauvé, a Member of the King's Privy Council, presented,—Return to an Order of the House of the 22nd February, 1932, for a copy of all correspondence, also the report of the Commissioner, made after the inquiry was held, in connection with the dismissal of Miss Gagne, postmistress at St. Pierre de la Riviere du Sud, County of Montmagny.

Also,—Return to an Order of the House of the 2nd March, 1932, for a copy of all correspondence, reports or other documents relating to the dismissal of Edouard Guy, postmaster at Kamouraska, Kamouraska county, Quebec; also a copy of all correspondence, reports or other documents in connection with an inquiry with reference to the charges brought against the said Edouard Guy, including the proof and evidence given by all the witnesses heard at said inquiry and the decision arrived at.

Also,—Return to an Order of the House of the 7th March, 1932, for a copy of all letters, telegrams, and correspondence exchanged between the member for Levis and the Solicitor General or the said member and the Postmaster General having reference to the cancellation of a mail contract on Rural Route
