## INCREASE IN CANADIAN EXPORTS-REQUEST FOR UNANI-MOUS CONSENT TO MOVE MOTION UNDER S.O. 43

Hon. George Hees (Prince Edward-Hastings): Mr. Speaker, I rise to ask unanimous consent of the House to move a motion under Standing Order 43 dealing with a matter of urgent public importance, specifically, that the increase in Canadian exports of 2.4 per cent during the first five months of this year, compared with the same period a year ago—

Mr. Baldwin: That is your consent, George—they are giving consent.

Mr. Hees: -is far less than the rate of increase-

Some hon. Members: Hear, hear!

**Mr. Hees:** —necessary to enable Canadian industry to absorb the yearly increase in the work force, thereby contributing materially to rising unemployment. I therefore move:

That the Minister of Industry, Trade and Commerce be required to appear before the Standing Committee on Finance, Trade and Economic Affairs within the next week, to discuss the need for a massive trade drive to increase exports to a level which will cause unemployment to decrease, rather than increase as it has been doing steadily since the beginning of the year.

#### VIET NAM—CANADIAN ROLE ON INTERNATIONAL CON-TROL COMMISSION—REQUEST FOR UNANIMOUS CON-SENT TO MOVE MOTION UNDER S.O. 43

This urgent matter concerns a report published in an American newspaper of international reputation and circulation. There are statements in this report which can reasonably be interpreted as reflecting with discredit upon the impartiality of Canada in discharging its role as a member of the International Commission for Supervision and Control in Viet Nam. I therefore move, seconded by the hon. member for Malpeque (Mr. MacLean):

That the Standing Committee on External Affairs and National Defence forthwith inquire into Canada's role and activities on the International Commission for Supervision and Control in Viet Nam, with specific reference to the question whether the representative provided by Canada on that commission at any time acted upon instruction by the Canadian government at the request of a foreign head of state without consultation with or knowledge of the representatives provided by other nations on the commission; and that the Secretary of State for External Affairs immediately table in this House all Canadian papers and documents pertaining to the messages carried or communicated to the government of Hanoi by J. Blair Seaborn while a member of the commission.
