# ISSUANCE OF COMMEMORATIVE STAMP—CALGARY 1975

### Question No. 1,827-Mr. Bawden:

Does the Postmaster General intend to issue a commemorative stamp on the occasion of the 1975 centennial of the founding of Calgary?

Hon. André Ouellet (Postmaster General): The 1975 centennial of the founding of Calgary is one of the subjects recorded for consideration in due course, but a final decision regarding the 1975 postage stamp program will not be made until late in 1974.

### PROVINCIAL BORROWING ABROAD

#### Question No. 1,831-Mr. Blenkarn:

- 1. To what extent has the government advised the provinces and provincial treasurers not to borrow money from foreign bankers, trust companies and other lenders in 1969, 1970, 1971 and 1972?
- 2. Is the government prepared to accept responsibility for increasing international exchange rates in connection with borrowings made by provinces in foreign markets that must be now repaid at current exchange rates?
- 3. Is the government prepared to direct provinces and municipalities that they may not, without specific permission from the Minister of Finance and/or the Bank of Canada, borrow money in foreign markets?

Hon. John N. Turner (Minister of Finance): 1. The former Minister of Finance, the Hon. E. J. Benson, requested provincial governments and agencies to limit their foreign borrowing in June 1970 at a meeting of federal-provincial ministers of finance following the floating of the Canadian dollar on June 1. The first formal request to Canadian borrowers to explore fully the Canadian capital market before floating issues abroad was included in a statement on economic policy by Mr. Benson on October 13, 1970 during debate on the Speech from the Throne. A letter was sent by the Hon. E. J. Benson to provincial treasurers and finance ministers and to investment dealers most active in international underwriting transactions on April 22, 1971, reiterating his request that foreign borrowing be kept to a minimum. A copy of the text of this letter was released April 23, 1971. The minister alluded to this request on several other occasions in the latter half of 1971. The subject was again discussed by federal and provincial senior officials at a Federal-Provincial Continuing Committee meeting in June 1972 and shortly thereafter the Minister of Finance visited his provincial counterparts to express concern over the level of foreign borrowing. From time to time through this period, the minister and his officials have been in touch with individual borrowers and investment dealers to discuss individual borrowings in relation to the minister's request. The Governor of the Bank of Canada made reference to the minister's request and concurred with this request in speeches made by the Governor in October 1970 and April 1971. The Bank of Canada also made note of this request in its Annual Reports for 1970, 1971 and 1972.
