VETERANS AFFAIRS**DISPOSITION OF GEORGE DARBY HOSPITAL LANDS—REQUEST FOR UNANIMOUS CONSENT TO MOVE MOTION**

In view of the recent announcement by the Minister of Health for the province of British Columbia that the provincial government was not interested in acquiring any land outside the hospital grounds of the George Darby Veterans Hospital in Burnaby, British Columbia, in view of the fact that federal government lands at Jericho in the city of Vancouver were returned to that city for the original purchase price, and in view of the fact that 9,000 residents of the municipality of Burnaby have petitioned for the return of the said lands, I move, seconded by the hon. member for Burnaby-Seymour (Mr. Nelson):
