- 3. Submissions have been solicited from the National Ports Council, since this body is composed of representative interests, including Harbour Commissions, the Local Port Authorities, National Harbours Board representatives, and officials of provincial governments, as well as officials of certain federal departments. The submissions were received, for the most part, prior to June 1974.
- 4. The development of a new administrative structure for ports is a complex task. The National Ports Council has the expertise necessary to examine the upcoming proposals, and because of its composition, it is considered to be representative of public and port user interests. It will be the focus for discussion of this issue prior to introduction of legislation. My reference to "greater participation in port-related decisions" refers to a principal characteristic of the new ports structure which we are trying to develop. That is, there would be a greater degree of local autonomy for the ports in future.

ESTABLISHMENT OF RAILWAY PASSENGER SERVICE TO FREDERICTON
