- 2. Canadian Government Office of Tourism, Department of Industry, Trade and Commerce.
- 3. Yes, such booklets are to be provided on a bon gratis basis.
- 4. Such brochures will be directed in terms of distribution mainly to the United States; to a lesser extent within Canada; to a very limited extent in Europe.
- 5. Thirty-five firms in six provinces were invited to tender of which the following companies submitted tenders: Ashton Potter Ltd., Toronto, Ontario; C. F. Haughton Ltd., Agincourt, Ontario; Rolph-Clark-Stone Limited, Bramalea, Ontario; Graphic Centre Ontario Ltd., Toronto, Ontario; Pierre DesMarais Inc., St. Laurent, Quebec; Ronalds-Federated Ltd., Montreal, Quebec; Gazette Canadian Printing Ltd., Montreal, Quebec; Montreal Lithographing Ltd., Laval, Quebec.
