## HEALTH—VIETNAMESE REFUGEES—HEPATITIS B VIRUS

#### Ouestion No. 383-Mr. Cossitt:

1. Is the Minister of National Health and Welfare aware of a bulletin issued by the Canadian Dental Association claiming that up to 7,000 of the 50,000 Vietnamese refugees being admitted to Canada are carriers of Hepatitis B Virus and that (a) the Canadian Dental Association has advised its members not to treat any of these people unless they have been tested to see if they carry such virus (b) provincial governments have been requested by the Canadian Dental Association to establish specific dental units for treatment of Hepatitis B Virus in major populated centres (c) Hepatitis B Virus is extremely dangerous and quite different from Hepatitis A Virus, normally found in Canada?

2. (a) What is the policy of the government on this matter (b) has the minister discussed it with provincial departments of health (c) what action has the department taken, if any, or is prepared to take?

# Hon. David Crombie (Minister of National Health and Welfare):

- 1. Yes, the minister is aware of the bulletin issued by the Canadian Dental Association claiming that 7,000 of the proposed 50,000 Indo-Chinese refugees may be carriers of hepatitis B virus.
  - (a) The minister has decided that all Indo-Chinese refugees arriving in this country will be tested for hepatitis B virus by the Canadian Red Cross blood transfusion service.
  - (b) The results of the tests carried out by the Canadian Red Cross laboratories will be forwarded to the appropriate provincial department of health within five to seven days of the blood specimens being taken.
  - (c) Although advice given to the department by experts has in general been reassuring respecting the potential risk of hepatitis B virus, a further program of testing of hepatitis B virus among the arrivals from Southeast Asia is being carried out by the department to establish the parameters of the problem and the most appropriate manner of dealing with it.
- 2. As mentioned, the policy at the present time is to carry out tests on all immigrants;
  - (b) The department has discussed this matter with all provincial departments of health who had been invited to meetings of an expert committee on refugee health problems over the past two months;
  - (c) The department, as mentioned, is prepared to take tests on all refugees of all age groups and the results of these tests will be made available to the provincial departments of health concerned.
