ADMINISTRATION OF JUSTICE

QUEBEC COURT ORDER FOR PRODUCTION OF DOCUMENT IN TRIAL OF RCMP OFFICERS

Mr. Donald W. Munro (Esquimalt-Saanich): Madam Speaker, my question is supplementary to those that have been directed to the Solicitor General. The minister will know that a justice of the Superior Court in the province of Quebec has ordered a defence witness to bring a document to the court. Is he aware that in preventing that document from reaching that court he is defying the court, and denying justice to a Canadian before that court who is seeking evidence in his defence?

Hon. Bob Kaplan (Solicitor General): Madam Speaker, I wonder if the hon. member is aware that it would be improper for me to comment on the evidence that is being asked for or being given before that trial that is now taking place in Montreal. I have been following the proceedings in the court. I know the document was searched for by the RCMP, and the witness from the RCMP went to give evidence about it.

Mr. Munro (Esquimalt-Saanich): The minister will be aware that he is obstructing justice in this country, and from a Solicitor General it is almost as bad as if the Minister of Justice were obstructing justice.

REQUEST THAT JUDGE BE PERMITTED TO SEE DOCUMENT

Mr. Donald W. Munro (Esquimalt-Saanich): Madam Speaker, my supplementary question is whether the minister will consider allowing that document to be presented to the judge for the judge to decide whether that document and its contents are relative to the course of justice and fairness to a Canadian who is being tried in that court.

Hon. Bob Kaplan (Solicitor General): Madam Speaker, as I understand the law, when it is a question of a document which deals with national security or with international relations, the responsibility of the minister is to make his own assessment of the document and not to put it before the court. If the law were different I would follow that different law, but the law is as it is, and I followed it as I understand it.
