Of this premium income only \$2,688,703 was paid to Canadian Companies, while \$10,486,116 was paid to Foreign Companies. The total amount of fire assurance premiums col-fected in Canada during these thirty-six years amounted to the enormous sum of \$201,-580,555. Of this amount \$156,600,789 was the amount of capital which left Canada in payment of premiums to Foreign Companies.

The Insurance Report shows that for the year 1904 there were but ten Canadian Companies licensed by the Dominion Government to transact the business of Fire Assurance in Canada, and but two of these ten had a paid-up capital for more than \$225,000. 


