I note that the Canadian Government concur in the view of this Government, as expressed in my note of April 28, 1924, that it is understood that the instructions drafted by the technical officers will be subject to approval by the respective Governments, before being given to the Engineering Board and also that these instructions will be submitted by the technical officers for Canada to the Canadian National Advisory Com-

In reply to your inquiry in regard to the publication of my note of April 28. I have the honour to inform you that it is entirely agreeable to me to release it for simultaneous publication in the United States and Canada in the afternoon press of May 9, 1924. In pursuance of an understanding reached by telephone between officers of the Department and Your Embassy, I am including your note of May 8 in the statement which this Department is giving to the press.
